A Message from Rep. Schweyer

If my first-grade teacher graded the performance of the PA State Government over the past six months, we would at best get an "incomplete." We passed a budget that included no increase in sales, tobacco or income taxes and included an additional \$100 million for our schools, but did so by borrowing against future revenues from programs like our Master Tobacco Settlement Agreement. This is, admittedly, a one-time fix for our seemingly endless budget problems.

We reauthorized our Children's Health Insurance Program and continued efforts to combat our opioid and heroin epidemics, while failing to pass a minimum wage increase or reduce property taxes for our seniors. We made significant strides on the implementation of our state's medical marijuana industry and reduced regulations to allow easier access of beer and wine to consumers. At the same time, we failed to even consider reforms to the process of legislative redistricting in an effort to end political gerrymandering.

There are a limited number of days scheduled for us to be in Harrisburg during the spring when we can consider these and other legislative priorities before important negotiations begin in earnest on the 2018-19 state budget. I will continue to prioritize funding for Allentown's public schools, programs that help create and maintain family-sustaining jobs and help provide access to health care for our children, seniors and those most at risk.

PLAN4PA

My colleagues in the House Democratic Caucus and I have introduced the Plan4PA which focuses on job creation, fair taxes, investment in education and health care. Before every major detail of our legislative package is ironed out, members of the House are on a



listening tour to learn from those on the front lines of these issues.

To that end, on January 10, colleagues from across Pennsylvania joined me at Good Shepherd Rehabilitation Network in South Allentown for a policy hearing focused on access to health care. There, we heard testimony from leaders in the health care community about how we, as policymakers, can help provide greater access to quality health care for all Pennsylvanians.

We learned about the need for access to preventative medicine as a way to control costs and improve health outcomes for patients. We learned about lack of mental health providers and the difficulties for vision and dental professionals to keep their doors open and we heard about the need for further investment in community health.

Did you know?

Disability placard

Even if you don't have a car or driver's license, you can still have a disability placard.

The reason is that a disability placard is assigned to a person, not a vehicle. That way, if you are getting a ride to the store or a doctor's visit from a friend or family member, you can still park in a space that makes your day a little easier. Yellow Dot

This program helps first responders who arrive at a vehicle crash know the specific health concerns of the passengers. By simply placing a Yellow Dot decal (provided by the state) on your vehicle's rear window, first responders will know to check your glove compartment for vital information to ensure you receive the medical attention you need. The program is a cooperative effort between the state departments of Transportation, Health and Aging, the Pennsylvania State Police, the Pennsylvania Turnpike Commission, first responders and local law enforcement. Help for seniors and veterans available in my district office



For our seniors: Each month, I host an APPRISE counselor in my district office to assist seniors with questions about Medicare and other health care-related programs. The APPRISE counselor can help you with Medicare Part A and Part B enrollment, prescription drug plans, Medicare Advantage plans and other health insurance options.

The APPRISE benefits counselor is available to meet with you from 10 a.m. to 2 p.m. on the third Tuesday of every month.

For our veterans: On the third Friday of every month between 10 a.m. and 2 p.m., a representative from the American Legion is available in my office to answer questions from veterans and their loved ones. This person has great knowledge about pension benefits, survivor benefits and VA-related health care issues; as well as other veteran-related benefits to which you may be entitled.

To meet with either the APPRISE counselor or American Legion representative, you must schedule an appointment. To arrange a time, please contact my office and speak

with any member of the team at 610-791-6270.







HELP WITH PA BIRTH CERTIFICATES

Have you lost or misplaced your Pennsylvania birth certificate?

NEW GUIDELINES FOR REAL ID

Following the attack on September 11, 2001, the federal government is requiring all states to update their state-issued photo identification cards (including driver's licenses) to include specific information. This law is known as Real ID. This is important to you, because in order to board a plane for a domestic flight or visit a federal office building, you will need a new identification card or driver's license (note: you will still be able to use a passport).

As of this printing, Real ID-compliant driver's licenses and identification cards will be available to Pennsylvania residents sometime in the spring of 2019. This date could change, but for now, you can continue to use your current Pennsylvania driver's license or state identification card (provided it is not expired) for domestic flights and to enter federal facilities.

The best thing you can do to prepare is to gather the acceptable documents now and keep them in a safe place because PennDOT will need to verify your identity, your Social Security number, and your Pennsylvania residency. Contact my office for a checklist of acceptable documents that you can take to any of the 71 PennDOT Driver's License Centers starting in September 2018 when they will all be equipped for verification.

Again, Real ID-compliant driver's licenses and state identification cards are scheduled to be available in the spring of 2019. You will hear more from my office in the weeks and months before to help ensure that you have no challenges flying to Florida or visiting Washington, D.C. office buildings.

To better serve residents in their own neighborhood, my district office staff holds community outreach hours from 2 p.m. to 4 p.m. on the first Monday of each month at Casa Guadalupe, 218 N. 2nd St. in Allentown.

Just like in my permanent district office at 1912 S. 4th St., my staff can assist you in all areas of state government, including completing Property Tax/Rent Rebate Program applications, processing PennDOT paperwork, finding heating assistance through LIHEAP, helping you work through the unemployment compensation process, assistance with the PACE/PACENET prescription-drug program, searching the unclaimed property database and any other state-related matter.
