A LOOK AT MY COMMITTEE ASSIGNMENTS

There are 27 standing committees in the Pennsylvania House of Representatives. Committees typically review a bill before it is brought to the House chamber for a vote. Members are appointed based on their expertise in specific areas, such as commerce, insurance and transportation, to name a few.

I have been appointed to serve on the following committees:

- AGRICULTURE AND RURAL AFFAIRS: This committee focuses on legislation that works to alleviate poverty and create fresh food initiatives.
- **COMMERCE:** This committee focuses primarily on legislation that expands jobs, businesses and trade.
- **ENVIRONMENTAL RESOURCES AND ENERGY:** This committee works primarily with legislation that expands energy resources such as shale energy while also ensuring that the environment is not harmed.
- **GAME AND FISHERIES:** This committee reviews legislation dealing with licensure and works to expand gaming and fishing in Pennsylvania.



SOME HIGHLIGHTS FROM THE GOVERNOR'S BUDGET ADDRESS

On Tuesday, February 6, Governor Tom Wolf gave his annual budget address. The governor discussed the proposed budget's goals of building a workforce and growing the economy, promoting 21st century jobs and skills, raising Pennsylvania's competitiveness, investing in job-creation programs and protecting our most vulnerable citizens. I think it is important to understand how the proposals can help Pennsylvania move forward, so I would like to discuss some highlights from the governor's address.

When discussing the notion of growing the workforce and building the economy, the governor addressed continuing investments in education and workforce development. The budget proposal includes an additional \$225 million to improve education for every student across the state, regardless of ZIP code. I was encouraged to hear the governor propose funding that could benefit our district's schools across the board.

The proposed budget also calls for a \$50 million investment in workforce development programs, including the launch of PAsmart — a workforce development initiative aimed at helping Pennsylvanians obtain career-training and job resources. The proposed funding

includes a \$25 million increase in STEM (science, technology, engineering and mathematics) and computer science-related education. Additional funding would expand apprenticeships and industry partnerships and further develop career and technical education. I support this funding as an investment that will help Pennsylvanians obtain the skills they need to compete in the job market.

To make Pennsylvania more competitive, Gov. Wolf discussed increasing the minimum wage to \$12 per hour, a proposal he estimates would reduce human services costs by \$100 million by adding money to the pockets of working families struggling to make ends meet. I agree that by increasing the minimum wage, we will be able to reduce the number of individuals who receive assistance from the Department of Human Services. This will ultimately lead to savings for taxpayers.

Additionally, the governor addressed how his proposed budget would continue to protect our most vulnerable citizens. The budget would continue funding for programs to target the opioid abuse epidemic. Other proposals provide for an additional \$74 million for services for individuals

with intellectual disabilities and autism, and new steps to enroll special education students who are transitioning to adult services in June 2019.

I agree with Gov. Wolf that we have a lot of work ahead of us but that we are continuing to write a new story.

I look forward to working with the governor and with all of my colleagues in the General Assembly to make you proud to call Pennsylvania your home.
