
Hello Regional Administrator Heckles and Deputy Administrator Lafollette –

Hope you two are well on this beautiful sunny day. I guess they say that "it's always sunny in Philadelphia . . ." I wanted to share this briefing sheet with you from Johnstown.

Johnstown understands that HUD officials cannot give specific assistance to a HUD grantee applicant in the middle of a solicitation, so we are just asking for thoughts and guidance on the general issues which the community is seeking to pursue for improved housing, connectivity, and opportunities for public housing families.

While Johnstown is a city of only 18,411 people in a relatively compact space because of the borders of the mountains and rivers, the 10 separate public housing community complexes managed by Johnstown Housing Authority are scattered across different neighborhoods and areas. So Johnstown has decided to focus on the 521 units located in 76 buildings of the Oakhurst and adjacent Coopersdale housing complexes. These are the oldest stock in the housing portfolio

(going back to 1943), the buildings have design and structural deficiencies, and they are essentially totally isolated pockets of poverty with no mix of workplaces, retail, health, education, institutional, park, or other community amenities available to the families living there. See Oakhurst and Coopersdale in the context of the city map, and in an aerial view below (two blue stars show where the housing complexes are, downtown labeled too):





So PHA Director Mike Alberts (copied here) reports that the HUD DCTA has commenced, and that the HUD consultant is gearing up to start some condition assessment work for the housing buildings that need the most work, which is all good. Our idea for what kinds of work Johnstown could do to build on this, to re-imagine the Oakhurst and Coopersdale housing to be better integrated into the community's assets, jobs, and revitalization efforts, is what the briefing sheet is about. Also the briefing sheet talks about some early actions that could be taken with initial resources to address what is most needed for the current 521 families in these complexes — improved public bus transit, mobility through the right kind of bike share, and a laundry facility at Oakhurst, which has none.

We thought it would be useful for you to understand some key next steps that Johnstown plans to take to keep the positive momentum going. Again, if you have any thoughts about this, we would welcome your guidance. Thanks much, enjoy the beautiful weekend, Matt Ward and Mike Alberts.





Lots going on in Johnstown, hope to follow up with you soon. I am overwhelmingly overwhelmed with some difficult deadlines due tomorrow 5pm, but I wanted to get this quick note out to you:

- 1.) Johnstown has launched its "Johnstown Quality Housing Task Force" officially, and is moving toward a later-March first convening of that Task Force, with the hope that the second convening will be a Task Force roundtable during your visit to Johnstown April 27-28.
- 2.) **Do you think April 27-28 will work for you?** We want to get the gears moving on planning.
- 3.) We have put together a run of show, activities while you are in town, etc. It is not public, so there is plenty of room for your input/changes. We should probably Zoom with you soon, to get your input, along with any other Regional Office, Pittsburgh Field Office, CPD officials, etc.
- 4.) This morning's news At one of the most functionally obsolete public housing complexes owned and operated by the Johnstown Housing Authority, called "Prospect Housing", a ceiling collapsed on a resident, injuring them. Structural engineers have determined that all 101 residents (families with children, elderly, lots of mix of people) need to get out, and get relocated. It is a difficult situation. The press is all over it, we expect the anti-public-housing politicians in the region to demagogue it, etc. Johnstown is in contact with HUD Pittsburgh. This is of course emblematic of the larger challenges with housing in Johnstown. Don't have an ask for you at this time, just an FYI.

Regional Administrator Heckles – Your email is very encouraging to the Johnstown team, and we are really pleased with your ideas and responsiveness. We have revised the Task Force briefing sheet and press release to incorporate your suggestions, including adding an explicit goal for public engagement on these issues, and those are attached.

We are going to convene the new Johnstown Quality Housing Task Force in mid-March for a kickoff and first meeting. Then we would like to convene the Task Force again in April, perhaps around the days of April 26-27<sup>th</sup>, if that could work for you and for any other HUD officials who come, such as HUD Pittsburgh Field Office's Housing and CPD leadership. We could choose other dates, but a team of Johnstown Housing Authority and other social/health service providers have a rotating "Wellness Wednesday" event in a public housing complex, and that April 26 could be a Wellness Wednesday at one of the major (and/or most distressed) complexes in Johnstown, and you could visit. It would have Public Housing Authority, community health, social service, and educational organizations, together with public housing resident families. Might be a good way for you to see one of the places.

Whatever the times, April seems like a good time to shoot for a visit. We would invite stakeholders from the key 20 organizations who are going to be on the Task Force (see pp. 1 and 2 of the Briefing Sheet), together with other city and county officials, and the public. We would suggest that most of the visit would be open to media, except for any portions that you desire or we suggest should be closed to press and/or public. Some ideas on an agenda follow – and we definitely would like to hear your ideas too.

- 1.) Welcome / Introductions / Framing Remarks from Johnstown Mayor Frank Janakovic, Johnstown Housing Authority Director Mike Alberts, and Quality Housing Task Force leader Jeannine McMillan.
- 2.) Hold a facilitated roundtable with all the members of the Task Force, with RA Heckles and HUD Pittsburgh Housing Director participating, to explore and discuss the issues.
- 3.) Give RA Heckles/HUD a community tour of the good, the bad, and the ugly, so to speak. Show key initiatives in economic and community development, show future hopedfor transformation plans, show public housing sites. HUD could come to one of the "Wellness Wednesdays" which the Housing Authority, the 1889 Center for Population Health, and others put on at housing complexes regularly. At that visit to a JHA housing

- complex, Heckles could have a sit-down with a smaller group, just involving human service/public health/educational/housing folks.
- 4.) Remarks from Phyllis Chamberlain, Executive Director of the Housing Alliance of Pennsylvania. <a href="https://housingalliancepa.org/staff/">https://housingalliancepa.org/staff/</a>. HAP promotes and advocates for policies, legislation, and programs dealing with low-income housing, housing affordability, and blight issues in PA. See HAPs Board of Directors they are a powerful group. <a href="https://housingalliancepa.org/board-of-directors/">https://housingalliancepa.org/board-of-directors/</a>. Chamberlain is now in discussions about getting engaged with Johnstown to help it address its tough issues.
- 5.) Remarks and workshop from Vin Tufo, Stamford CT housing director who started the "Vita" health and wellness initiative there.
- 6.) Remarks/address by RA Heckles. This can be at any point right after the Mayor's opening of the workshop, later in the program as a kind of "reaction" to what you have heard and seen, or perhaps remarks at both the beginning of the visit, and later in response to the activities in the visit. We are open to what works best for you.
  - One idea: Johnstown is going to submit shortly an application for HUD's "Community Compass Technical Assistance & Capacity Building" assistance. This would focus on bringing in on-call HUD contracted housing experts, for a community-based assessment of how to deal with Johnstown's issues, particularly the issue of how to handle the most obsolete and distressed complexes, and how best to deal with rehousing for any units decommissioned, demolished, converted to rentals, or otherwise transitioned in use. HUD Compass applications are rolling, not competitive, and able to be awarded based on an application. It would be exciting and appreciated if HUD selects Johnstown for Compass Community TA, and you could announce this in your visit to the community.
- 7.) Have some kind of closing session in which an "action agenda" is adopted and next steps for the Task Force are laid out.
- 8.) During this visit, a smaller group would host Mr. Heckles and any other HUD visiting officials for a nice dinner (dutch treat if appropriate).

We have a few good community venues that could hold this roundtable and workshop.

Let us know what you think. Also, although some of our team have discussed the potential agenda for a visit, others have not had a chance to weigh in yet, and we are planning a Zoom for mid-next week to discuss. So the agenda ideas might get improved by this time next week.

Your timing is very good! I was just thinking about you and the city of Johnstown the other day and received this communication just before I was to write to you requesting an update. I must say that I am very happy to receive it and thrilled that it contains such good news. I believe deeply that the formation of this task force will significantly advance the cause in Johnstown.

One short editing note: My appointment was made by the President but it did not (thankfully!) require Senate confirmation.

On the substance... I think the composition of the task force is excellent. I think it is appropriate and good to mention the important initiatives that are already underway and I think the goals are very good too. I would like for you to consider including one additional component – public engagement. I think it is in there in subtext but I think it should be elevated – the task force should pick up and continue the work started and engage in new activities but it ought to also bring in the citizens of Johnstown to educate them about the true situation and challenges but to gather their input for what the city needs, should advance and the vision it should strive to accomplish.

I will share this with my team and we will set up a time to discuss the visit. It is not a matter of 'if' but 'when and how' – you have had my commitment already. I would love to hear your ideas on what that visit looks like – do you have them already? Perhaps we can start a document to outline the type of events so that we can fill in the details – logistics / invitees / format / etc... I've got a few thoughts but would love to hear yours...

I'll ask my folks to get a meeting on the books for you to meet the key players on our team and start to put this all together.
