

PROPERTY TAX/RENT REBATE PROGRAM IS BETTER THAN EVER!

The Pennsylvania Legislature significantly expanded the Property Tax/Rent Rebate Program in 2023 to help more people than ever qualify for a rebate on their rent or property taxes. This historic law delivered the **largest targeted tax cut for Pennsylvania seniors in nearly two decades.**

More than 520,000 Pennsylvanians received a rebate last year, including more than 100,000 who received a rebate for the first time.

This year, more Pennsylvanians will qualify for a rebate because of increased eligibility limits.

NEW! INCOME LIMIT FOR 2025 TAX YEAR: \$48,110

ELIGIBILITY TABLE FOR HOMEOWNERS AND RENTERS

| INCOME | MAX REBATE |
|---------------------|------------|
| \$0 - \$8,550 | \$1,000 |
| \$8,551 - \$16,040 | \$770 |
| \$16,041 - \$19,240 | \$460 |
| \$19,241 - \$48,110 | \$380 |

NOTE: Claimants may deduct half of any Social Security – including Medicare premiums – or Railroad Retirement Tier 1 benefits from their income when determining eligibility. Federal disability and state veterans' benefits also may be excluded when applying. This means that a renter or homeowner could have a higher household income and still qualify for the rebate program.

ELIGIBILITY CRITERIA:

Applicants must be 65 or older, a widow or widower 50 or older, or disabled and 18 or older.

ATTENTION

You **MUST** bring the following documents with you to complete the process:

- Total Social Security/Railroad Retirement
- Proof of SSI or Disability
- Proof of Age- first time filers – Driver's License or Photo ID
- 1099 Pension Statement(s)
- 1099 Interest Statement(s)
- 1099 Dividend Statement(s)
- Proof of W-2 or Other Income if received
- Voided check showing Routing and Account Numbers for direct deposit

In addition, the following documents are necessary if appropriate:

- Property owners: Proof of Taxes Paid, stamped or signed by tax collector.
- Renters: Completed Rent Certificate signed by landlord.
