## Rep. Bizzarro pans governor's budget proposal

Gov. Tom Corbett's proposed state budget is more of an election-year ploy than a credible fiscal plan for Pennsylvania.

Despite the fact that the governor proposed an increase to special education and a few other education-related appropriations, it was disappointing when he decided to offer only modest increases to certain programs while excluding others. His plan will not begin to undo the harms his past policies have inflicted on Pennsylvania.

The proposed funding will do little to address the 20,000 education jobs lost, the widespread property tax increases and the countless lost opportunities. Obviously, the governor is making no effort to restore the massive cuts he made to colleges and universities.

The governor's budget proposals come at the expense of the state's retirement systems, increasing the debt by \$13 billion over the next three decades and putting the burden on the backs of future generations.

It is this kind of irresponsibility that got us into a hole in the first place. Simply put, this is a cut-and-spend budget.

The biggest disappointment was the lack of a game plan to improve

Pennsylvania's economic climate and ability to compete in the global marketplace.

The state is among the worst in the nation in job creation under this governor, ranking 48th among all states in job creation and 41st among all states in projected job growth. Unfortunately, the governor offered little to reverse this damage.

While states surrounding Pennsylvania are showing budget surpluses and recovering economies, Pennsylvania faces a \$1.4 billion budget deficit and little hope on the horizon from the governor. After three years of disappointment, it's time for change in Pennsylvania. The legislature is an independent branch of government and does not have to pass what the governor proposes.



I believe the governor's proposed budget lacks initiatives to move Pennsylvania forward, especially on the critical issues of job creation and public education.

# Rep. Bizzarro's measure honors teen epilepsy victim

National Epilepsy Awareness Month and recognizes July 27, 2014, as 'Pay it Forward Day' for what would be Alyssa Josephine O'Neill's 19th birthday. Alyssa's tragic death last September from an epileptic seizure could not stand

without marking the worldwide campaign launched on her behalf to combat epilepsy.

Alyssa's bravery, kindnesses and beauty live on, and her life is reverberating through the hearts and efforts of people across the globe via social media.

Alyssa's story went global with a Facebook page about Alyssa and epilepsy. Instagram users posted thousands of photos with the #ajo hashtag, while thousands of tweets with

the hashtag were logged to promote Alyssa's Twitter page and epilepsy awareness campaign on Facebook and Twitter.

The Erie area took Alyssa into their hearts, and the 'AJO Forever in our Hearts' effort has since blossomed with businesses and social media embracing Alyssa's story and the efforts to find a cure for epilepsy. The worldwide attention to Alyssa's life and story is inspiring to all.

## Protecting women in the workplace

I am excited to be supporting bills that protect and respect women in the workplace.

A woman earns 84 cents on average for every dollar a man makes, and that gap hurts not just the woman but her entire family. It's time to bolster family incomes by updating pay-equity efforts.

I am proudly backing H.B. 1890, which would update the conditions where employers could pay different wages because of factors other than sex to include specific, job-related attributes such as education, training and experience.

The bill also would strengthen anti-retaliation protections for workers attempting to bring a pay-equity lawsuit against their employer and those who share information about their pay.

Eliminating the pay gap would provide 89 more weeks of food, more than seven more months of mortgage and utilities payments, and more than one year of rent. Studies indicate more than 17,000 children just in Erie County are wholly

dependent on mothers' income. Clearly, we can reduce dependence on government assistance by injecting more fairness.

Women in Pennsylvania, on average, are earning \$694 a week while their male peers are earning \$849, a pay gap that requires women to work more than an additional three months to make up the difference.

Many factors contribute to the pay gap, but discrimination is a major cause. Families suffer when we allow myths to justify paying women less for the same work.

I am also supporting H.B. 1984, which would prohibit employers from discriminating based on a job applicant's marital or parental status.

Irrelevant and inappropriate questions about marital and parental status – such as if an applicant plans to have children – have no place in Pennsylvania workplaces.

My staff and I offer specialized assistance every month for military veterans at my constituent service office in the Peninsula Plaza.

Help always is available for our veterans, but on the second Tuesday of every month we partner with the state American Legion to provide service specifically geared toward veterans. No appointments are necessary, and veterans do not have to be American Legion members to participate.

Greg Luce, an American Legion service officer, will be at the office – 1101 Peninsula Drive, Suite 209 – from 10 a.m. to 2 p.m. on the second Tuesday of every month to assist veterans living in the 3rd Legislative District.

Specialized assistance will be available on a wide range of issues affecting veterans, including:

- Compensation and pension claims;
- Education benefits;
- VA health care enrollment;
- Burial and survivor benefits; and
- Obtaining personal military documents, including medical records.

Help on any state-related matter still will be available to any resident at the same time. However, on the second Tuesday of every month we will devote time and attention to veterans, just as they deserve.

# Edinboro, Washington Township joining the 3rd Legislative District

Come December, the 3rd Legislative District that I now represent will have a new look.

Edinboro and Washington Township will join the district.

The changes are coming because the state constitution requires that legislative districts be redrawn every 10 years to reflect population shifts and to ensure accurate distribution of state and federal money.

Most of the current 3rd Legislative District will not be affected by the changes. Remaining in the district will be McKean Township and McKean Borough, as well as Districts 2 through 24 in Millcreek Township, with the exception of District 21.

The changes do not affect your township, borough or school district affiliation. Again, the transition will take effect in December 2014.

## Rep. Bizzarro takes stand against elder abuse

I have introduced two bills aimed at protecting a growing segment of Pennsylvania's population, its senior citizens.

My House Bill 2006 takes aim at the increasing thefts of prescription medications from older adults. The legislation would create new categories of theft offenses – and create mandatory minimum sentences – for those convicted of stealing, extorting or deceiving seniors of their medications.

The second measure, House Bill 2007, would make financial transactions made on behalf of an incapacitated individual through a power of attorney agreement to be more readily used as evidence.

Amazingly, current law does not enable investigators to petition courts to secure such financial documentation if an older adult is unable to provide their consent because of their incapacitation.

H.B. 2007 also would insert into power of attorney documents a warning that a failure to comply with the documents' directives could result in criminal charges.

Both bills are before the House Judiciary Committee for consideration and would help protect older and vulnerable Pennsylvanians from abuse.

## Lighting the night

Last year, the state House of Representatives unanimously approved my House Resolution 403 to spotlight support and recognize September as "Light the Night Walk Month" in Pennsylvania.*
