## **CORBETT BUDGET HITS FEW HIGH NOTES, MANY LOW NOTES**



The governor's 2014-15 budget failed to gain any Democratic support because it continues to ignore the realities of life in Pennsylvania.

- Education funding, which was reduced in Gov. Corbett's first budget by nearly \$1 billion, has not been restored. Accumulated loss continues to negatively impact schools.
- Our schools are increasing property taxes the maximum amount allowed by law and still need to cut programs, staff and even teachers just to survive.
- More than 400 of the 500 public school systems in Pennsylvania have had to raise property taxes during the past three years.
- Failure of the state to pay its share to the school and public employee retirement funds has forced schools to use money that should be spent on teaching our children to try to make up for years of unpaid retirement funds instead.
- 20,000 teachers and staff have been laid off statewide; many right here in the Mon Valley.
- Fewer teachers mean larger class sizes and fewer opportunities for students.
- Valuable programs such as art, music and foreign languages have been cut in some schools.
- Schools are also considering eliminating or reducing kindergarten programs and even physical education.

Article III Section 14 of the Pennsylvania Constitution states:

The General Assembly shall provide for the maintenance and support of a thorough and efficient system of public education to serve the needs of the Commonwealth.

This budget, like the governor's previous budgets, fails this basic constitutional test.

## Higher education also continues to suffer under this governor.

- Pennsylvania ranks 47<sup>th</sup> in per-capita spending on higher education.
- State-related schools such as Pitt, Penn State, Temple and Lincoln incurred a 19% cut three years ago.
- State-related schools like Pitt and State System of Higher Education schools received no additional funding, forcing tuition increases of about 3%.
- Pitt and Penn State both cost more than \$16,000 per year and are already the two most-expensive public universities in the country. Temple is the sixth most-expensive.
- The national average annual tuition for an in-state resident at a public university is about \$7,400.
- Funding for State System schools such as IUP, Slippery Rock, Clarion and Edinboro were cut by 18% three years ago. This funding shortage has been locked in with no increases since Gov. Corbett's cuts were enacted, forcing them to reduce programs and staff, including professors.

# NEW LAW BENEFITS SENIORS ON PACE/PACENET

A new law I co-sponsored benefits nearly 50,000 seniors in Pennsylvania who qualify for discounted prescriptions through the state's PACE/PACENET programs. One of the main qualifying factors in determining if a senior is eligible for PACE/PACENET is their income.

About 40,000 seniors were in danger of losing their PACE/PACENET coverage because Social Security cost-of-living increases would put their income just over the maximum. A previous COLA adjustment law was set to expire Dec. 31, 2013. This new law extended the protection to Dec. 31, 2015.

In addition, the law enabled approximately 8,200 additional seniors to access PACE/PACENET by no longer requiring applicants to count their Medicare Part B premium as income.

These changes are now in effect, so those who recently applied, but were turned down, should contact one of my constituent service offices to find out if they now qualify.

#### Who is eligible?

#### To be eligible for PACE and PACENET:

- You must be 65 years of age or older.
- You must be a Pennsylvania resident for at least 90 days before the date of application.
- You cannot be enrolled in the Department of Public Welfare's Medicaid prescription benefit.
- PACE and PACENET eligibility is determined by your previous calendar year's income.

#### PACE

- For a single person, total income must be \$14,500 or less.
- For a married couple, combined total income must be \$17,700 or less.

#### PACENEI

- For a single person, total income can be between \$14,500 and \$23,500.
- For a married couple, combined total income can be between \$17,700 and \$31,500.

#### **PACE Plus Medicare**

■ Under PACE Plus Medicare, PACE/PACENET coverage is supplemented by federal Medicare Part D prescription coverage and offers older Pennsylvanians the best benefits of both programs. Older adults continue to receive the same prescription benefits while, in many cases, saving more money.

## UPMC/HIGHMARK AGREEMENT STILL SHORTCHANGES PUBLIC NEEDS

The good news is that UPMC and Highmark have decided not to burn their bridges with each other and their affected patients. The bad news is they have not announced a definitive long-term agreement to guarantee that all those with quality medical insurance will not be forced to change either their doctor or their insurance carrier.

*The highlights of the recent agreement include:* 

#### Highmark cardholders will continue to have innetwork access to the following UPMC facilities:

- Children's Hospital of Pittsburgh
- Hillman Cancer Center
- UPMC Mercy
- Western Psychiatric Institute and Clinic
- UPMC Hamot and Kane Hospital
- UPMC Horizon
- UPMC Northwest
- UPMC Bedford
- UPMC Altoona

With certain exceptions, effective Jan. 1, 2015, the following UPMC hospitals will be out-of-network for Highmark cardholders:

- Magee-Women's Hospital
- UPMC Presbyterian-Shadyside
- UPMC Passavant
- UPMC St. Margaret
- UPMC McKeesport
- **UPMC** East

Some provisions of the agreement include:

- Allowing continuity of care for those currently receiving treatment for any illness at any UPMC facility for as long as the patient and doctor deem necessary
- Vulnerable populations including those on Medicare, Medicaid, CHIP, Medigap, and Signature 65 will have continued in-network access
- Patients undergoing oncology treatment will maintain in-network access, including the treatment of illnesses resulting from cancer
- In-network access for emergency room visits


While these are generally positive steps, the fact that some people with good insurance plans will be excluded from a number of quality medical centers **MUST** be addressed. My Western Pennsylvania colleagues and I will continue to look for a permanent, fair agreement to ensure all who have insurance maintain access to their current physicians.

## **ROAD AND BRIDGE UPDATES**

#### W.D. Mansfield Bridge - Dravosburg

- \$35 million project is nearing completion; final phase under way
- All ramps leading on and off bridge complete
- Underpass to Glassport complete
- Two-lane traffic limit remains, so continue to use caution
- Expected to fully open to traffic October 2014
- Railing installations expected to be completed December 2014

## Homeville (Thompson Run) Bridge – West Mifflin

- ☐ County bridge project scheduled to close summer 2015 through end of 2016
- Cost estimate \$12 million

#### Route 51/88 intersection

- A recent traffic switch was just completed, allowing for phased construction of culvert and bridge replacements on Rt. 51
- Major utility relocations continue; next phase changes to be announced at a later date
- ☐ Final cost: \$19 million

#### Skyline Drive, West Mifflin

- Shoring up and repaying section of Skyline Drive at crest of hill; associated guiderails to be repaired
- Engineering study to be initiated soon

## S.R. 885 Bridge over Union Railroad in West Mifflin


- Replacement of concrete arch bridge over Union Railroad with a single-span bridge

## **38TH LEGISLATIVE DISTRICT CHANGES TAKE EFFECT DEC. 1**

McKeesport and two districts in West Mifflin will be leaving as of Dec. 1.

## REP. KORTZ'S CURRENT LEGISLATION

- home inspectors to be licensed in Pennsylvania. Currently, home inspectors do not need a license and are generally not held liable for errors in their reports. This bill is currently being considered by the House Professional Licensure Committee.
- April 16, 2013 Urged the Pennsylvania Supreme Court to protect police by building in a time delay before dissemination of information about arrest warrants. The Supreme Court has announced it will follow this protocol.
- police departments to use radar for speed enforcement. Pennsylvania is the only state that prohibits local police departments from using radar. Whitehall Borough Mayor Jim Nowalk and Police Chief Donald Dolfi both endorse this proposal. This bill is currently under consideration in the House Transportation Committee.

## New veterans designation available on driver's licenses



I wanted to let you know that veterans can now have their veteran status recognized on their driver's license.

Anyone who served in any branch of the U.S. Armed Forces or National Guard and was released or discharged

with anything other than a dishonorable discharge is eligible to receive the veteran designation added to their photo license for no charge. You will need to provide proof of discharge such as a DD214 or similar documentation.

Once the designation has been added to your license, it will remain on your license through future renewals.

There are many instances when proof of veteran status may be valuable. This will allow you to provide the necessary proof without carrying valuable documents with you at all times.
