## **Kids' health insurance wins well-deserved extension through 2017**

I wholeheartedly supported passage of House Bill 857, which was signed into law by Gov. Tom Wolf as Act 84 in December. This legislation reauthorizes and extends the life of the Children's Health Insurance Program – CHIP – until Dec. 31, 2017.

CHIP was slated to expire at the end of 2015, which would have resulted in over 150,000 children losing insurance coverage.

CHIP has offered no-cost or low-cost health care coverage for children under 18 whose parents make too much to qualify for Medicaid but cannot afford private insurance.

CHIP coverage includes routine doctor visits, prescriptions, dental appointments and eye care, along with immunizations, mental health, durable medical equipment, rehabilitation therapies, home health care and autism-related services.

Monthly premiums for the program are based on each family's income. More importantly, families enrolled in CHIP will not see any changes to their eligibility, co-payments, benefits, coverage or even their cards with passage of the new law.

Act 84 also transfers the administration of CHIP from the Department of Insurance to the Department of Human Services, which also oversees the state's Medicaid program.

The change helps coordinate coverage and is a cost-saving maneuver that will enable the state to use one information technology system to manage eligibility determination for both programs.

Thanks to the efforts of hundreds of area residents, I have been informed by the U.S. Postal Service that there are no plans to close or further reduce the hours of operation at the Wabash Station post office branch.

I launched a petition drive in August to save the West End facility, noting it is a crucial community link not only for the community's many older residents but also for its continuing revitalization efforts.

The postal service seems to have taken the message to heart, assuring me in writing that there are no plans currently to

close or further reduce the hours of operation.

As I have said repeatedly, the neighborhood needs this facility as it forges a new future.

Since the petition effort was launched, I have received reports that the branch has been a beehive of activity and commerce.

Please be aware that my office at 436 S. Main St., Pittsburgh, can notarize documents needed for local, state or federal programs for free.

This includes PennDOT applications for a handicapped parking placard or plate, or a duplicate title. We can also notarize applications for unclaimed property.

Please call the office at 412-928-9514 with any questions. No matter where you get documents notarized, please remember not to sign any forms until you are in front of the notary and bring a valid photo identification card.

# FREE help available with Property Tax/Rent Rebate Program

My office has received current Property Tax/Rent Rebate Program applications from the state Department of Revenue – and my staff is ready to assist!

The rebate program benefits eligible Pennsylvanians 65 or older, widows and widowers 50 or older, and people with disabilities 18 or older.

Claimants must reapply for rebates every year because rebates are based on annual income and property taxes or rent paid annually.

Please take note of two changes to the program that I supported:

- Social Security cost-of-living adjustments will no longer disqualify those applying for a rebate; and
- Claims filed on behalf of claimants who lived at least one day during the claim year and meet all other eligibility criteria will be paid.

The oft-extended deadline to apply for a rebate on property taxes or rent paid in 2015 is June 30, 2016, and rebates

normally are distributed beginning July 1. So, the sooner you file, the sooner you will receive your money!

**Please ignore offers to assist with filing the application for a fee. My office offers help at no charge, and the Revenue Department does not charge a fee to process your application.**

## Beware of IRS scams in our area

Please be aware that fraud artists are still peppering area residents with a phone and email scam in which imposters claim to be from the Internal Revenue Service and ask for personal financial information.

Please be aware that the IRS will **NOT** initiate first contact with you about taxes owed through a phone call or email.

Always be wary of unsolicited phone calls in which an individual claims to be representing a business or government entity and aggressively demands payment. The IRS will always send official correspondence through the mail to make its first contact with you.

### Additionally, it is important for you to know that the IRS:

- Never asks for credit card, debit card or prepaid card information over the telephone.
- Never insists that taxpayers use a specific payment method to pay tax obligations.
- Never requests immediate payment over the telephone and will not take enforcement action immediately after a phone conversation.

### Other characteristics of these scams include:

- Scammers use fake names and IRS badge numbers. They generally use common names and surnames to identify themselves.
- Scammers may be able to recite the last four digits of a victim's Social Security number.
- Scammers spoof the IRS toll-free number on caller ID to make it appear that it's the IRS calling.
- Scammers sometimes send bogus IRS emails to some victims to support their bogus calls.
- Victims hear background noise of other calls being conducted to mimic a call site.

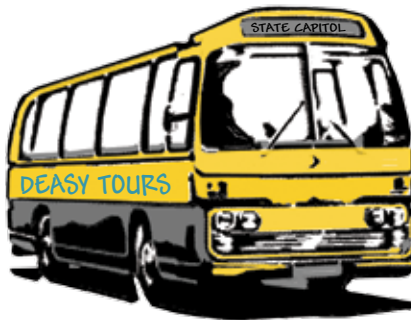

## Sign up for email updates

I want to alert you to House rules that limit when I can contact you leading up to an election. **Unless you specifically opt in to continue receiving my emails**, I'm prohibited from sending you legislative email updates for 60 days before the 2016 primary and general elections.

**Opting in will allow you to continue to receive notices about important issues that matter to you, including:**

- Updates on legislation;
- News and events in the district; and
- Other relevant government-related information.

## PennDOT program can provide help in emergencies

Please be aware of a program offered by PennDOT that helps people immediately after a traffic accident when they may not be able to communicate their needs to police and first responders.



It's called the Yellow Dot Program. It gets your emergency contact and medical information promptly into the hands of emergency personnel at the scene of a crash.

Under the Yellow Dot Program, you fill out a form with your emergency contact information, medical history and medical contact information and put this information, along with a photo of yourself, in your vehicle's glove compartment. A yellow dot sticker goes on your back window. This sticker will alert first responders to check your glove compartment for your information in an emergency.
