State budget update

After multiple attempts to pass a responsible spending plan containing increased education funding and property tax relief, political gridlock has prevailed.

The budget impasse has lasted long enough, and I'm frustrated and embarrassed that we haven't been able to agree on a comprehensive plan that addresses the needs and wants of Pennsylvanians. We shouldn't have to send our children to schools that are in danger of closing because they aren't fully funded, just as our food banks, rape crisis centers and other human service organizations must get the support they need for the long haul to serve our most vulnerable Pennsylvanians. In addition, our parents and grandparents shouldn't be priced out of their homes because of skyrocketing property tax rates. Pennsylvanians deserve better.

Online voter registration now available in Pennsylvania

Recently, the state launched a website to make it easier for you to register to vote and participate in elections. You can access it by visiting: www.votesPA.com.

The new website is available in English or Spanish and it also allows you to make updates to your voter record, such as change of name, address or party affiliation. You can also request assistance at a polling place.

The site is directly linked to the Pennsylvania Department of Transportation's Motor Voter systems, so if you have a driver's license or PennDOT ID card, your signature on file can immediately be linked to your voter record.

If you do not have a driver's license or ID card, you can print, sign and mail the completed online application to your county voter registration office. If you are unable to print the application, you may request the Department of State mail you a signature card to complete and send back.

Free veterans assistance available



There's good news for veterans in the 3rd District: My office provides a free Veterans Assistance Program each month at my Millcreek office located at 1101 Peninsula Drive, Suite 209 in the Peninsula Plaza!

From 10 a.m. to 2 p.m. on the second Tuesday of every month, veterans can meet with service officers to see if they qualify for certain benefits, learn about helpful programs and ask any questions they may have about available services.

My legislation

I have sponsored several pieces of legislation this session that I believe would vastly improve our communities and our state. As always, I would appreciate your feedback on these and other measures!

Preventing animal cruelty

My H.B. 869 is designed to prevent animal cruelty by requiring people convicted of animal abuse to forfeit abused animals to shelters. Moving animals to shelters, instead of returning them to their abusers, would not only keep our animals safe, but it would also cut down on the need for further seizure costs and frequent checks from law enforcement officers.



Looking after our veterans

I held a news conference in Harrisburg with state Sen. Rob Teplitz on my H.B. 887, which would establish a veterans' court in any Pennsylvania county without one. Erie County already operates its own court, which allows veterans charged with nonviolent crimes who suffer from service-related addiction

and mental illnesses to enter a rehabilitation program with veteran mentors. If they are successfully rehabilitated, the charges are dropped, saving counties thousands of dollars and greatly helping the men and women who have sacrificed for us.



Caring for older Pennsylvanians

I am proud to report the House passed my H.B. 299, designed to combat elder abuse committed by people with power of attorney. The bill would require the state's Power of Attorney Acknowledgment to indicate that failure to comply with the document's directives, which can result in theft or fraud, could bring about criminal charges. I have also introduced H.B. 511, which would amend state law to add theft offenses and corresponding minimum mandatory sentences for taking or extorting, disposing of, or deceiving to acquire prescription medications from adults older than 60.

Making voter registration more convenient

Last year, I held a news conference at the state Capitol to unveil my H.B. 13, which would provide for same-day voter registration in Pennsylvania, allowing people to register to vote at their polling place on Election Day. Interested voters would need to supply specified proof of identification and their current address, and their ballots would not be counted until their applications were verified by the Pennsylvania Department of State.



Protecting our children

My H.B. 2012 would add adrenoleukodystrophy (ALD), a lysosomal storage disorder, to the list of genetic diseases for which hospitals must screen newborns in Pennsylvania. This disorder affects the nervous system and can be fatal if not treated before symptoms arise. ALD can be detected through the same heel prick newborns are already subjected to under the Newborn Child Testing Act, so it only makes sense to test for this disease, too.



Improving access to health care

My H.B. 1113 would have the state Health Department establish regulations to certify community paramedicine providers, allowing them to practice and treat patients throughout the state. It would also require insurance coverage and medical reimbursement for these services. Community paramedicine is an effective way for patients to be treated, and I believe it should be more widely available for patients whose injuries and ailments are not life threatening.

I was proud to present a \$93,000 check to McKean Township for the McKean Community Park Trail Expansion Project, designed to create a walking and nature trail. The funds were awarded by the Commonwealth Financing Authority.

Home heating help now available

Do you need help heating your home? If so, I urge you to consider applying for the Low-Income Home Energy Assistance Program, known as LIHEAP. This particular program helps low-income families pay their heating bills and deal with such heating emergencies as a broken furnace, fuel shortage or utility service shutoff.


If you're living in a family of four and have a household income less than \$36,375, you qualify for LIHEAP. More eligibility requirements can be found on the state Department of Human Services' website at www.dhs.pa.gov, and clicking "Heating Assistance/LIHEAP" under the "Citizens" tab at the top of the page.
