
I plan to bring the issues of our legislative district to the table during all committee meetings and hearings.

New Property Tax/Rent Rebate applications, help available



My district office has received Property Tax/Rent Rebate Program applications for eligible residents to begin claiming rebates on property taxes or rent paid in 2016, and the staff is ready to help!

The rebate program benefits eligible Pennsylvanians 65 or older, widows and widowers 50 or older, and people with disabilities 18 or older. The income limit is \$35,000 a year for homeowners and \$15,000 annually for renters. Half of Social Security income is excluded and the maximum standard rebate is \$650.

Claimants must reapply for rebates every year because rebates are based on annual income and property taxes or rent paid annually. Spouses, personal representatives or estates may file rebate claims on behalf of deceased claimants who lived at least one day in 2016 and met all other eligibility criteria.

The rebates normally are distributed beginning on July 1. So, the sooner you file, the sooner you will receive your money! The deadline to apply, for now, is June 30, 2017, but it is routinely extended until the end of the year.

Please ignore offers to assist with filing the application for a fee. My office offers help at no charge, and the Revenue Department does not charge a fee to process your application.

More sessions scheduled in April



I am gratified by the community response to the Heroin & Opiate Community Awareness Town Halls I sponsored in Crafton and Beechview with state Sen. Wayne D. Fontana.

The town halls presented the scope and complexity of the addiction epidemic taking a toll across our community and nation.

Residents heard the latest, eye-opening accounts of the scourge from representatives from the state Attorney General's Office, the Allegheny County District Attorney's Office, local district magistrates, the Allegheny County Sheriff's Office and Department of Human Services, local law enforcement and treatment experts.

The Allegheny County Deputy Sheriff's department also provided information about Project D.U.M.P., an initiative to help residents safely eliminate unused and unwanted medications. I thank residents who took the opportunity at the town halls to dispose of unneeded medications through the program.

We have additional town halls scheduled and they are detailed below.

The Allegheny County Sheriff's Office will be on hand at both meetings – Monday, April 10th at the Mt. Washington Senior Center and Thursday, April 20th at the McKees Rocks VFW – to collect unused medications for safe disposal.

Deasy partnering with Port Authority

Ticket machine on tap at West End office

In an effort to streamline services, the Port Authority of Allegheny County has made some changes when using bus and rail services.

On Jan. 1, the Authority implemented a flat-fare system that encompasses the entire service area. Riders pay \$2.50 a ride with a ConnectCard, or \$2.75 with cash. Riders may purchase transfers for \$1 with a ConnectCard. Transfers allow for one additional ride in any direction aboard a connecting vehicle and are valid for three hours.

The half-fare transfer price is 50 cents for riders with a Reduced Fare ConnectCard. Riders with passes do not need transfers. Transfers are not available for cash-paying customers. Cash-paying customers must pay \$2.75 for each ride.

Because riders with a ConnectCard pay a lower base ride fee, and because a ConnectCard is now required to make a transfer, I wanted to ensure that my constituents have easy access to a Port Authority machine to purchase a ConnectCard. I have worked with the Port Authority and the owners of the building where my district office is located to have a Ticket Vending Machine (TVM), installed outside of my office at 436 S. Main St., in the West End.

My office is located on the bus route, so having access for riders to reload their ConnectCard in the West End just makes sense. The TVM machine will allow riders to purchase a ConnectCard, reload a card, check their card balance, or purchase Connectix, which is a pre-paid pass for an individual ride.

Please note that the machine is owned and operated by the Port Authority. Any information on bus routes or about the ConnectCard will still be directed to the Port Authority at 412-442-2000 or by visiting its website at www.portauthority.org.

60-day tax amnesty program opens April 21

Program**

Pennsylvania's 2017 Tax Amnesty program will be offered from April 21 through June 19, and will enable individuals and businesses to pay past-due taxes with all penalties and half of the interest waived.

More than 30 state taxes administered by the PA Revenue Department are eligible for tax amnesty, including the Personal Income Tax, Corporate Net Income tax, sales and use tax, employer withholding tax and inheritance tax.

Eligible are individuals and businesses with unpaid or underpaid state taxes as of Dec. 31, 2015, as well as taxpayers who failed to file for periods due on or before Dec. 31, 2015. A similar tax amnesty program offered in 2010 collected \$254 million.

Guide explains responsibilities for road maintenance, traffic signals

In Pittsburgh and surrounding municipalities, roadway maintenance, traffic control and other infrastructure issues are not sole responsibilities of the Pennsylvania Department of Transportation.

It is important that constituents know the correct authorities to whom they may express their concerns.

In Pittsburgh, street maintenance is a shared responsibility between the city and the state. PennDOT maintains the roadway between the curbs, including inlet grates. However, sidewalks, guiderails, and roadway drainage systems that exist beyond the curbs are the city's responsibility.

Likewise, all traffic control devices – including signs, pavement markings, and signals within city boundaries – are also maintained by the municipality, not the state.
