Opposition grows to White Haven Center proposal

In July, legislation was introduced in Harrisburg to close, by 2023, the White Haven Center and others like it across the state for those living with intellectual disabilities.

I have opposed this measure from Day 1 and I will continue to work with my colleagues to protect the residents of White Haven Center and their families. Earlier this year, when the governor and Department of Corrections proposed closing our local state prisons, Sen. John Yudichak and I led the charge against the plan and prevented it from happening. We will work closely to oppose this misguided idea as well.

The residents and families of the White Haven Center rely on

the facility for special services that otherwise would not be available to them. I met with them and center officials in July to discuss the legislation.

The center also provides hundreds of jobs for the local community and has a tremendous economic impact in the region.

The legislation has been referred to the House Health Committee. I encourage you to contact Chairman Rep. Matthew Baker to express your opposition to H.B. 1650. His phone number is 717-772-5371.

During the White House visit, I was able to meet with many of the officials with whom I contact to solve your problems.

The conference was coordinated by the White House Intergovernmental Affairs team and included discussions among senior-level federal agency officials, including Office of Management and Budget Director Mick Mulvaney, and members of the Pennsylvania House of Representatives.

Heating aid via LIHEAP opens Nov. 1

The 2017-18 Low-Income Home Energy Assistance Program – LIHEAP – will begin accepting applications for heating assistance grants Nov. 1.



LIHEAP offers cash grants of \$200 to \$1,000 that are sent directly to the utility company to defray heating costs for eligible households, and crisis benefits of \$25 to \$500 for households in immediate danger of being without heat.

Once the program opens, please consider visiting my offices if you need help filing a LIHEAP application.

The state Department of Human Services, which administers the federally funded LIHEAP program, will mail applications or information to people who received LIHEAP grants last season.

Because of uncertain federal funding, DHS has decided not to issue supplemental payments to vulnerable households during the season. If additional funds remain after the season has concluded, DHS may issue supplements at that time.

This season's income guidelines for both LIHEAP cash and crisis grants are \$18,090 for an individual, \$24,360 for couples and increases for each additional person in the household.

Bill would help ease burden on club licensees

Club licensees that fall under the Local Option Small Games of Chance Act would have easier reporting and fundraising duties, under legislation that I introduced in the House of Representatives.

Currently, state law requires clubs with proceeds exceeding \$20,000 in a year to submit annual reports. These reports provide information on proceeds from each game of chance and the amount of prizes awarded, itemized weekly.

My legislation would change that requirement from weekly to quarterly.

My bill does not change the information provided to the state – it simply eases the reporting timeline. Filling out this necessary paperwork would not be as burdensome for our veteran and fraternal organizations and other nonprofit clubs.

House Bill 1334 also would increase the fundraising limit from \$40,000 annually to \$60,000 annually, allowing clubs to satisfy their charitable mission.

The legislation awaits action in the House Gaming Oversight Committee.

Nanticoke Police receive drug collection grant

Congratulations to the Nanticoke Police Department on receipt of a drug collection unit grant.



The unit is located in the lobby of the Nanticoke municipal building and provides residents with a safe and environmentally responsible way to dispose of unwanted, unused or expired medication, including controlled substances. The drop-off site is open from 8:30 a.m. to 4:30 p.m. Monday through Friday and drugs can be dropped off with no questions asked.

I was proud to work with Chief Tom Wall, the Pennsylvania District Attorneys Association and the National Guard Counterdrug Joint Task Force at Fort Indiantown Gap to bring this service to Nanticoke. This will greatly help get unneeded drugs out of medicine cabinets and homes throughout the city and region.

Property Tax/Rent Rebate Program deadline extended

Your hard-earned money goes toward a lot of property tax and rent. Why not get some of that back? You now have more time to apply for this refund.

The deadline for filing with the 2016 Property Tax/Rent Rebate Program has been extended to Dec. 31.

This program benefits eligible Pennsylvanians 65 or older, widows and widowers 50 or older, and people with disabilities 18 or older. The maximum standard rebate is \$650, but supplemental rebates can boost your return to \$975.

Get Property Tax/Rent Rebate claim forms (PA-1000) and related info online at www.revenue.pa.gov, by calling toll free 1-888-222-9190 or from my office. We are ready to help you understand the program, complete the application, and get some money back.

Please don't assume you are not eligible. The income limit is \$35,000 a year for homeowners and \$15,000 a year for renters. Half of Social Security income is excluded. Spouses, personal representatives or estates may also file rebate claims on behalf of claimants who lived at least one day at the residence and meet all other eligibility criteria.
