## WORKING FOR YOU

### PA STATE BUDGET DELIVERS FOR PARKLAND

Ensuring a bright future for our children is a moral responsibility we have as a society. Each child deserves access to world-class education and I am committed to fighting for it every day I am in office.

The 2018-19 budget has good news for the Parkland School District. For the upcoming school year, the state's commitment to Parkland will rise to \$12.1 million, marking a 25% increase in the state's support for our students since the 2012-13 school year.

These resources will help the leadership of the Parkland School District to continue offering the world-class education students deserve.

Equally important, the 2018-19 budget was approved with broad bipartisan cooperation. Bipartisanship needs to be more than a catchphrase. It needs to be a way of governing and budgets like this need to be the expectation for the General Assembly.

### Gun Violence: Time to Say "NO MORE!"

It seems each year the rash of gun violence across the country gets worse as mass shootings in schools, churches and public places continue to make headlines. People often ask, "How many kids have to die before we do something?" I am committed to every measure that helps to answer: "No more!"

Thankfully, there has been a change in tone because Americans are mad and they expect action to curtail gun violence in our communities. In Harrisburg, measures intended to take guns out of the hands of violent abusers came out of the Judiciary Committee with bipartisan support.

I welcome all of these developments to ensure public safety and look forward to the opportunity to make progress on these issues in the fall. I also firmly believe we need to further enact policies that address gun violence where it is affected by mental health. On several occasions, I have supported efforts to increase funding available for mental health services while watching efforts in Washington — including attempts to repeal the Affordable Care Act — undercut federal commitments to supporting those mental health services. It simply is not enough — or accurate — to say mental health is a threat to community safety: we have to actually pay for the services!

# Progress on Mental Health

Mental health continues to be an area of focus for me. A recent report from the U.S. Centers for Disease Control and Prevention showed suicide rates have increased by more than 34% since 1999 in Pennsylvania. We have a lot of work to do to ensure mental health services are in place to protect human life from the devastating effects of neglected mental health. Here are a couple of measures I've pushed in the last few months:



## #StrongMomStrongBaby

At the start of the session, Rep. Tarah Toohil (R) and I re-introduced legislation to add postpartum depression to the list of conditions that would make early intervention services available for children. We called the legislation, #StrongMomStrongBaby. In June, that legislation passed the House 196-0. The legislation was referred to a Senate committee where it must be passed in order for Gov. Tom Wolf to sign it into law. This legislation would allow 8,000 more children in Pennsylvania to access existing early intervention services. Families deserve to know support is available when mom needs it most.

## Suicide Prevention Fences

In June, Gov. Wolf signed legislation that included language I introduced to require PennDOT to consider protective fencing during the design process on bridges in locations where there is a known suicide problem. The fencing envisioned in this amendment was a key part of the 8th Street Bridge renovation in Allentown. The bridge has a sad history of being the place where a number of people have attempted or completed suicide by jumping off the bridge. Since the fencing was installed, that hasn't happened and I have no doubt it has saved lives. Simply by reducing a person's access to lethal means to complete suicide, a person has the opportunity to escape crisis and find help.

## Bringing Harrisburg to Allentown

### Red Means Stop: This is What Democracy Looks Like

In 2017, Amber Clark came to my office with an observation: too many motorists ignore the stop sign mounted on school buses. She came armed with a petition signed by hundreds of people asking for Pennsylvania to take steps to make rides to school safer. Amber had done some research on what other states have done to make it easier to enforce the law requiring other drivers to stop when that stop sign is deployed and lights are flashing.



Working with Sen. Pat Browne, PennDOT, law enforcement and school officials, we were able to introduce legislation that would make it easier to catch drivers. Since then, Amber and her daughter Olivia have continued to do advocacy work to build public support for this legislation, helping it to advance in the Senate.

Amber and Olivia help to illustrate an important lesson: Democracy still works for those who take responsibility for the common good.

### Pathways to Pardons

Working with Reps. Schweyer and McNeill, I hosted a Pathways to Pardons forum with support from the lieutenant governor's office. They covered a variety of important topics to help people get answers to questions they have about the pardon process in Pennsylvania. # Honoring Our Veterans

## License Plates



You don't need to be a veteran to show your support of veterans by purchasing the "Honoring our Veterans" license plate. This plate is available for motorcycles, passenger cars and light trucks up to 10,000 lbs. My office has the application for this special plate and can submit it and payment to PennDOT to ensure proper processing. Give us a call at 610-821-5577 or bring your vehicle registration information to my office at 2030 W. Tilghman St. in Allentown.

The price of the "Honoring Our Veterans" license plate is currently \$36 and \$15 from the sale of each license plate goes to the Veterans' Trust Fund to assist and support Pennsylvania's veterans and their families. ## Veterans Registry



Pennsylvania is always looking for ways to better serve our veterans. One way to find information about services for veterans is through the Pennsylvania Veterans Registry. This online portal links veterans, family members, and employers of veterans to the Department of Military and Veterans Affairs to more easily find information on state programs, services, and benefits for veterans. ## Veterans and Spouses Burial Information

Veterans and their spouses may be eligible for interment in one of the three open national veterans cemeteries maintained by the U.S. Department of Veterans Affairs. The three cemeteries in Pennsylvania are: National Cemetery of the Alleghenies, Indiantown Gap National Cemetery and Washington Crossing National Cemetery.

Burial benefits are available to eligible veterans and include a gravesite, a government headstone, a flag and a Presidential Memorial Certificate.

My office has information about eligibility for interment and contact information for each of the three national cemeteries in Pennsylvania.



## American Flag Collections

Throughout the year, my office collects American flags to be turned over to a community group for proper retirement. This year, people delivered more than 200 flags to my office. Those flags were retired by the Lehigh County Office of Veterans Affairs as part of a Flag Day ceremony. We will continue to collect flags year-round. You can bring them to my office at 2030 W. Tilghman St. in Allentown.



## No longer Using a License Plate?

A lot of people don't know what to do with a license plate when selling a car. Bring it to my office!

It is important to know unused license plates may continue to be your responsibility even after transferring the title. This means you may be responsible for anything that happens with that license plate, including things like parking tickets or tolls.

When selling a car, if you don't plan to reuse the license plate, the safest thing to do is to retain possession of the license plate and return it to PennDOT through my Allentown office. We'll ensure safe delivery to PennDOT at no expense to you. If you have any questions about a plate you still hold, please give my office a call at 610-821-5577.

# News For Seniors

## PTRR Deadline Extended

In 2017, across Pennsylvania, approximately 548,000 people claimed over \$262 million in rebates on rent and property taxes. Gov. Tom Wolf extended the deadline for this program from June 30 to Dec. 31, 2018.

The Property Tax/Rent Rebate Program is open to:

- Eligible seniors 65 or older;
- Widows and widowers 50 or older; and
- People with permanent disabilities 18 or older.

To qualify, applicants must earn less than \$35,000 per year (for homeowners) or \$15,000 per year (for renters) – and only HALF of Social Security or railroad retirement benefits count toward eligibility. Residents of assisted living facilities may be eligible if they reside in a facility which pays property taxes and meet the income limits for renters. If you're eligible – or you know someone who might be – my office can help you file the application and answer questions. Just stop by 2030 W. Tilghman St. in Allentown, or call 610-821-5577 and I will mail you the information.

## Medicare Open Enrollment

Do you know everything you need to know about your Medicare coverage? If you join a private Medicare or prescription plan, your details could change and it could cost you. Medicare open enrollment begins Oct. 15 and ends Dec. 7. My office hosts a specially trained Apprise Counselor to help you understand your benefits. When open enrollment begins, this person will be available on Tuesdays from Oct. 16 to Dec. 4. Give my office a call at 610-821-5577 to schedule your appointment. While this seems like it's far away, don't delay in making an appointment as there are limited spots available and they go fast.
