## LEGISLATIVE UPDATE

As we enter a new year, lots of legislation is on the agenda. Here are some of the bills I will be working on. If you have any questions or would like more information on these, please contact my office.

- Hotel Workers Protection Act Inspired by harrowing media reports and modeled on legislation enacted or under consideration in other states, I am introducing legislation to provide "panic button" devices to hotel employees working alone in servicing guestrooms.
- Drug Prices Legislation Even with insurance, prescription drug prices are putting strains on family budgets. We can do better, which is why I am supporting legislation to help lower drug prices in Pennsylvania.
- Alina's Law I've joined with other lawmakers to support legislation to prevent another tragedy like that which befell Alina Sheykhet, a 20-year-old who was killed in 2017 despite having a PFA against her abuser.
- Human Trafficking Legislation Earlier this year
  the House voted to move a series of bills aimed at
  combating human trafficking in our state. It is my
  hope that the Senate will move to quickly confirm this
  legislation and that it will be signed into law.
- Social Club Liquor License Reform Another bill
  that was passed by the House and is awaiting Senate
  action is my legislation to allow community social clubs
  to save their liquor licenses in the event of extenuating
  circumstances.
- Raising The Wage Despite a compromise bill that passed the Senate but was blocked in the House, raising the minimum wage remains one of my key priorities for 2020.



- Workers' Bill Of Rights A comprehensive package of bills toward bettering or supporting workers' rights and the most proactive agenda for workers our commonwealth has seen in decades.
- Volunteer Fire/EMS Help Last year the House voted to approve a number of bills which, among other things, would enact tuition assistance and loan forgiveness for volunteers, exempt volunteers from paying realty transfer tax, provide loan forgiveness for college graduates, provide online training to first responders and increase access to mental health care for volunteer first responders who suffer from trauma. Many of these bills are currently awaiting a vote in the Senate.

## **New law list for 2020**

- "Do Not Call" Law: The strengthened "Do Not Call" law
  went into effect in December. Under the new law, telephone
  numbers registered with the state database no longer need
  to be re-registered every five years. Business telephone
  numbers also may be added to the "Do Not Call" list. To
  register your telephone number or to get more information
  on the new regulation, please visit the Pennsylvania
  Attorney General's website.
- Licensure Reform: This law seeks to reduce the "red tape" surrounding out-of-state occupational licenses.

  This will particularly benefit military families who move to Pennsylvania by making it easier for their spouses to work.
- PA GI Bill: This law extends tuition benefits to Pennsylvania National Guard (PANG) members' spouses and children.
   If the service member chooses to re-enlist for six years, their family may attend college at no or reduced cost. This

- program is the first of its kind in the nation. In addition to supporting military family members, this program would also improve PANG retention and enhance its readiness.
- Farm Bill: The goal of this package of laws is to create
  more jobs, expand resources and heighten interest in one
  of Pennsylvania's most prosperous industries agriculture.
  They provide personal income tax credits for farmers who
  sell or lease their land to new, beginner farmers, build upon
  resources within the dairy industry to help with marketing,
  and help fund the continuous fight against the detrimental
  spotted lanternfly.
- Sunday Hunting: Pennsylvanians will soon be able to hunt on three Sundays per year; once during archery deer season, once during firearms deer season and an additional Sunday as selected by the Pennsylvania Game Commission. This law will go into effect February 2020.
