Working for you in a new legislative session

I'm honored to have begun a new term as representative for the 161st Legislative District. The past year was incredibly difficult for so many people, and my staff and I continue to help our neighbors in the district navigate the challenges the pandemic has thrown our way.

Last year, while following COVID-19 safety protocols, we helped with more than 1,080 unemployment cases and assisted thousands of residents with state services and questions through phone and email.

I am committed to fighting in Harrisburg to get help for those who need it, including local small businesses, frontline workers and emergency responders. I was pleased that in early February, the General Assembly passed, and Gov. Tom Wolf signed, legislation to allocate nearly \$1 billion in COVID-19 relief to those who need it. The bill included more than a half-million dollars in emergency rent relief plus \$145 million for the Hospitality Industry Recovery Program to support restaurants and bars, and more.

It's a start, but we have a lot more work to do to address the devastating impact that the COVID-19 pandemic has had on our community.

Fighting for a budget that works for you

In February, Gov. Wolf presented his proposed 2021-22 state budget.

His proposal includes efforts to make Pennsylvania more equitable, fairly fund schools, invest in public health and support workers and businesses. Notably, he also proposes increased funding to support 10 existing county and municipal health departments around Pennsylvania – and create an 11th in Delaware County. That would be welcome news for our community.

The governor's budget is a starting point, and over the next few months, we will be working to negotiate a final budget by the end of June. There are things in his proposal that I support and some things that I have concerns about.

The House Appropriations Committee recently concluded a three-week series of hearings on the budget, and as a member of that committee, I used those opportunities to raise my concerns and ask questions about the issues that matter to you, the residents of my district. I'm grateful for everyone who took the time to call or email with your budget questions!

Be alert for unemployment compensation fraud

The Pennsylvania Department of Labor and Industry has urged residents to be vigilant against fraud.

Anyone who has not applied for unemployment benefits is likely a victim of fraud if they:

- Receive unrequested unemployment paperwork from L&I's Office of Unemployment Compensation.
- Receive unemployment benefit payment(s) from the Pennsylvania Treasury that they did not apply for.
- Receive 1099G tax forms for 2020 indicating they were paid unemployment benefits.

If this has happened to you, you can report the fraud online at www.uc.pa.gov or call the PA Fraud Hotline at 1-800-692-7469.

Remember: L&I never contacts anyone and asks for their username, password, PIN or full Social Security number. Additionally, L&I does not communicate with claimants over social media, and the only valid email addresses to contact Pennsylvania's Unemployment Compensation Service Center are uchelp@pa.gov and ucpua@pa.gov.

Supporting emergency services in Delco

Our first responders always protect our communities in times of emergency, and that's been even more apparent as we've battled COVID-19.

I was proud to support Act 26 of 2020, which made \$50 million in grants available for fire and EMS organizations affected by the pandemic. Locally, grants were awarded in October as follows:

In late December, I was thrilled to announce that a **\$1.5 million Redevelopment Assistance Capital Program grant** was awarded to strengthen Delaware County's 911 system.

The challenges with our existing system are well-documented, and I have spoken to local police and firefighters who have lost radio contact during emergency calls because of issues with the old system.

This grant will help fund 24 tower upgrades to provide acceptable county-wide communication coverage, shelter structures, an ice bridge, grounding, electric, HVAC, core work additions and 911 center equipment to communicate effectively in emergency situations with citizens, first responders and with surrounding counties in southeastern Pennsylvania.

I organized legislators from both sides of the aisle to help secure this funding, which will better equip emergency responders to receive and answer calls throughout all of Delaware County, safely.

Grants awarded in the 161st District

I'm happy to help local government agencies and organizations seek grant funding to support their work for our communities. Here's a look at some additional grants coming to our area:

- **Brookhaven Police Department:** \$25,000 state grant to help fund equipment to enhance public safety.
- **Folsom Athletic Association:** \$20,000 Keystone Communities grant for a sports field lighting project.
- **Schoolhouse Senior Center:** nearly \$5,000 grant to support its work helping local seniors.
- **Delaware County Technical High School – Aston:** \$7,147 grant to upgrade cafeteria equipment.



My office teamed up with Delaware County District Attorney Jack Stollsteimer's office to host a shredding and prescription drug takeback event, following COVID-19 safety guidelines, in Aston in October.

More than 400 people brought materials for shredding, and we collected 150 pounds of medication for proper disposal. I'm grateful to serve our community and help individuals protect themselves from identity theft and other scams. I hope to see you at our next shredding event in April!

Legislative update

This session, I have introduced bills to help local nonprofit organizations survive the pandemic; protect health care workers from violence; and support K-9 teams with proper training. Here are more details, and you can find more information on these and other bills at legis.state.pa.us.

H.B. 347: Nonprofit organizations help connect families to resources they need during difficult times, offer us opportunities to experience arts and culture, and so much more. The pandemic has deeply impacted these organizations, so I've introduced legislation that would establish the COVID-19 Nonprofit Assistance Grant Program by allocating \$100 million in COVID-19 recovery funding to the Department of Community and Economic Development.

H.B. 348: Health care workers in hospitals and other facilities face significant risks of workplace violence. They care for us in times of need, so we must work to protect them as well.

This bill would create the Healthcare Facilities Violence Prevention Act, which would require health facilities to establish a workplace violence prevention committee, require the mandatory reporting of instances of workplace violence, and protect employees from retaliatory action for reporting workplace violence, among other things.

H.B. 349: Our state and local K-9 teams work to keep us safe and are a great example of the dedication of our law enforcement services. However, non-standardized training

can create drastic learning curves between the two.

I've heard from local K-9 officers about the challenges they face, so I've introduced this bill to require the Municipal Police Officer's Education and Training Commission to work together with the State Police to establish K-9 team and K-9 specialty team training and certification standards following national standards. This would help us support our K-9 teams and ensure they have the training they need.



RGGI: Pushing for real action on climate change

The Pennsylvania Environmental Quality Board wrapped up a public comment period in January on proposed regulations that would reduce carbon dioxide pollution from power plants within Pennsylvania and establish Pennsylvania's participation in the Regional Greenhouse Gas Initiative.

I testified virtually before the Environmental Quality Board in support of RGGI and the urgent need to take action.

Climate change is already impacting Pennsylvania. We have experienced record-breaking extreme storms, serious flooding, and our agriculture and winter tourism industries have already been impacted.

But as we began another legislative session, I found myself immediately needing to push back against efforts to block Pennsylvania from joining RGGI.

At the first House Environmental Resources and Energy Committee meeting, the majority of the committee voted to send a letter to the PA Independent Regulatory Review Commission disapproving of Pennsylvania joining the Regional Greenhouse Gas Initiative.

I opposed that action, and I'll continue fighting for real action on climate change.

Property Tax/Rent Rebate for 2020

You can now file your 2020 Property Tax/Rent Rebate Program application online through the Department of Revenue's myPATH system. Visit mypath.pa.gov to file your application or call my office if you need assistance.

The rebate program benefits eligible Pennsylvanians age 65 and older; widows and widowers age 50 and older; and people with disabilities age 18 and older. The income limit is \$35,000 a year for homeowners and \$15,000 annually for renters, and half of Social Security income is excluded.

The maximum standard rebate is \$650, but supplemental rebates for qualifying homeowners can boost rebates to \$975.

SEPTA Key Senior Cards extended


Because of COVID-19, all SEPTA Key Senior Cards that expired in 2020 and those set to expire in 2021 have been extended through the end of calendar 2022.

You can apply for a SEPTA Key Senior Card by appointment only. Call 215-580-7145 for an appointment.

Real ID: New enforcement date is Oct. 1, 2021

Beginning Oct. 1, 2021, Pennsylvanians will need a Real ID-compliant driver's license, photo ID card, or another form of federally acceptable identification (such as a valid passport or military ID) to board a domestic commercial flight or enter a federal building or military installation that requires ID.

You do not have to get a Real ID. To learn more and decide if you need a Real ID, visit penndot.gov/REALID.
