## Combating the tangled title crisis

More than 10,000 homes in Philadelphia have unclear owners and are caught in what's called a tangled title. This often happens when a person is living in a house that is still in the name of a deceased loved one, like a parent or grandparent.

Tangled titles threaten to keep people from qualifying for home repair assistance or taking out a loan, leave them vulnerable for deed theft, and prevent them from selling or even keeping their house. Research shows areas with tangled titles have higher rates of gun violence, poverty and blight.

In December, I teamed up with the Philadelphia Register of Wills for a webinar to detail the financial and legal aid available to untangle titles and ways to prevent them from happening.

## Home heating help is available

Pennsylvania's Low Income Home Energy Assistance Program is again accepting applications.

LIHEAP helps eligible individuals and families cover heating bills through a one-time cash grant sent directly to their heat provider that does not have to be repaid.

Households in immediate danger of being without heat may also be eligible for crisis grants.

Make sure to call my office for help applying for LIHEAP along with information about other financial assistance that utility companies are offering to keep your home warm this winter.

### Securing stop signs to improve safety

For more than ten years, our Webster Street neighbors fought to get stop signs on 61st and 62nd streets after seeing far too many accidents and other safety concerns.

This fall, I worked alongside state Sen. Anthony Williams, Councilmember Jamie Gauthier, and the Philadelphia Streets Department to deliver results.

I am proud to report that stop signs were placed on 61st and 62nd streets reaching from Catherine Street to Cobbs Creek Parkway.
