## **LEGISLATIVE UPDATES**

### IMPROVED PROPERTY TAX AND RENT REBATE PROGRAM

Pennsylvania's Property Tax and Rent Rebate Program is getting better for thousands more Pennsylvanians thanks to legislation we passed last year – the first program expansion since 2006.

#### Starting in 2024:

- The income limit to qualify for rebates is raised to \$45,000 for both homeowners and renters.
- The income cap will keep pace with inflation.
- The maximum rebate increases from \$650 to \$1,000.

These much-needed increases will help more than half a million older people and people with disabilities, both renters and homeowners, stay in their homes and communities.

### CHILD AND DEPENDENT CARE TAX CREDIT INCREASED

Families who qualify for the federal Child and Dependent Care Tax Credit are eligible for the state tax credit, which was previously equal to 30% of the federal credit.

Pennsylvania will now provide a 100% match to the federal tax credit. Families will see their state tax credits more than triple.

- It's money back for child care expenses.
- It's money back for dependent care expenses.
- And: if you qualify, you'll receive the money after you file your 2023 tax return in a few weeks.

If you qualify for the federal credit, you qualify for the state credit.

- The one child credit of \$180 goes up to as much as \$1,050 depending on household income and expenses.
- The current two-or-more children credit of \$360 goes up to as much as \$2,100 depending on household income and expenses.

Below is a list of some of the bills that I co-sponsored and that are important to residents of the 27th Legislative District based on feedback I received during the year. I hope that some of these bills will make their way through the process and become law before the end of the current legislative session – which is Nov. 30, 2024. (Please note Act 13 and 14 are the two exceptions, as they have already been signed into law).

### **WORKERS' RIGHTS**

**H.B. 950** would guarantee workers the right to organize and collectively bargain in the commonwealth. Currently, the Pennsylvania Constitution does not guarantee workers that right.

**H.B. 760** would update the unemployment compensation system by providing working Pennsylvanians injured on the job options to receive their benefits via direct deposit. Currently in Pennsylvania, the workers' compensation system is still dependent on mailing physical checks, leaving these payments vulnerable to delays or misplacement.

#### **CONSUMER PROTECTION**

**H.B 636**, known as the Pay the Price You See Bill, would mandate fee transparency in all advertised pricing for goods and services sold in the commonwealth. Consumers get hit with "junk" fees at the end of a transaction and they are inherently deceptive and should not be allowed.

**H.B. 828**, known as the Stop Price Fixing Act, would enable the state attorney general to prosecute individuals and businesses that collude to artificially raise the prices of goods and services.

### **ENVIRONMENT**

**H.B. 1302** would require the PA Department of Environmental Protection to forward notices of noncompliance issued by the federal Environmental Protection Agency for violation of the state and federal law to the municipality where the violation occurred.

**H.B. 1474** would add electric vehicle charging infrastructure projects as an eligible project type under the C-PACE program. This would help businesses that want to make these types of investments and continue our progress in developing statewide electric vehicle charging infrastructure.

**H.B. 1476** would impose a two-year moratorium on the issuance and renewal of certain air permits related to cryptocurrency mining. The moratorium would apply to permits for electric generating facilities that provide behind-the-meter electricity to crypto mining operations that use proof of work authentication. The bill would also require the PA Department of Environmental Protection to conduct an impact study on cryptocurrency mining and create reporting requirements for cryptocurrency operations.

### **VETERANS**

**Act No. 13 of 2023 (H.B. 404)** allows members of the military to keep current licenses, registrations, and certifications from the Department of Health – such as EMS – from meeting requirements of continuing education or in-service training while serving. At discharge they have one year to renew, or the agency must determine if the licensing requirements have already been met through experience, training etc. or if those requirements can be waived.

Act No. 14 of 2023 (H.B. 804) ensures that military families are guaranteed Pennsylvania in-state tuition rates as soon as a student submits the enrollment deposit, even if a parent (parents) are reassigned out of state.

**H.B. 1963** would make it explicit that spouses of veterans are entitled to receive veteran's preference death certificates, which are free.

# \$7.8 MILLION CAME BACK TO THE DISTRICT FOR PROJECTS IN 2023

Bringing state dollars back to the 27th Legislative District is an integral part of what I do as your state representative. Local programs are a vital source of meeting needs for residents, and I am focused on making sure the 27th District gets its fair share of funding for those programs.

Projects range from the fresh fruit and vegetable program for local schools to a municipal storm sewer project. These are all important projects to our local landscape.

Below is a list of just some of the projects funded in the last year -

- City of Pittsburgh Neighborhoods Funding for the West End and Mt. Washington Healthy Active Living Centers, tax credits for Mt. Washington CDC and Global Links, funding for building repairs for Pittsburgh Musical Theater.
- Crafton Funding for streetscape project including new lights, landscaping, and EV charging stations.
- Green Tree Trumball Drive Bridge Replacement and pollution reduction plan funding.
- Heidelburg Funds to replace aging dump truck used for snow removal and hauling community refuse.
- Ingram Funding for Foster Park, updated traffic signal at Ingram Ave & Prospect Ave as well as funding for traffic calming initiative along Ingram Avenue.
- Rosslyn Farms -- Funding to rehab Parrish Park and new storm sewer funding.
- Scott Storm sewer improvements and funding for new Public Works storage facility.
- Thornburg Funding for sanitary sewer system rehabilitation and sidewalk replacement projects.

### NEW OFFICE LOCATION BUT COMMITMENT TO THE WEST END REMAINS

Working with Pittsburgh Regional Transit to keep the ConnectCard Vending Machine in the West End

While my office has relocated to Green Tree because of reapportionment, my commitment to the West End has not wavered. In 2017, I worked with the Port Authority (now Pittsburgh Regional Transit) and pushed to have a Ticket Vending Machine (TVM) located outside of my West End office to ensure bus riders would be able to get a bus pass and reload their bus pass right in the neighborhood.

When my office had to relocate last year after reapportionment and PRT was going to remove the TVM, I got to work on finding a way to keep the machine in the West End. I contacted PRT and the Carnegie Library system to advocate for the machine to be placed near the Carnegie Library-West End Branch. I am optimistic that we can reach an agreement to keep the machine in the neighborhood as PRT, the Carnegie Library and I are all committed to serving the West End Community.
