

2018-19 ALCOHOL AWARENESS POSTER CONTEST GUIDELINES

The Pennsylvania Liquor Control Board, Bureau of Alcohol Education's 2018-19 Alcohol Awareness Poster Contest is an artwork competition focusing on the prevention of underage drinking and healthy alternatives to underage alcohol use. All Pennsylvania students in kindergarten through 12th grade, including home-schooled, parochial and private schools, may submit artwork. Please read the following carefully. If you have questions, contact the Bureau of Alcohol Education at 717.772.1432 or RA-LBEducation@pa.gov. Complete the entire entry form with signed parental consent. **Any posters with an incomplete release form will be disqualified**. Every submission must have a completed entry form attached to the back of the poster, tape is preferable.

Students wishing to enter should include clear, POSITIVE no-use messages and images about avoiding underage drinking and alcohol use. For example, artwork about the benefits of being alcohol-free or alternatives to underage drinking are acceptable. Themes such as prom, homecoming, back-to-school, graduation or seasonal holidays (Halloween, Thanksgiving, Christmas, etc.) are encouraged.

- Use any medium, but keep in mind that winning posters must be in a format that can be reproduced.
- Do not submit posters with 3D designs.
- Artwork must be no larger than 11" X 14". Those exceeding the measurements will be disqualified.
- Consider using another language and include the English translation on the entry form.
- Pack artwork so that it remains flat during shipping.
- Team entries are not allowed—do not submit posters created by more than one person.
- Artwork that includes any reference/image of tobacco or other drugs will be disqualified.
- Artwork with negative images, like graves, death symbols, prison cells, car crashes, etc., will be disqualified.
- Artwork with copyrighted or trademarked characters such as comic, television or movie characters or using logos or trademarked names of specific products such as brands of liquor or other beverages, or that include any political references, images or messages will be disqualified.
- Artwork posters with inappropriate language or symbols or images which are discriminatory will be disqualified.

Qualifying artwork will be judged on message, creativity and artistic ability. Consideration will be given to the student's grade level.

All submissions become the property of the Pennsylvania Liquor Control Board and will not be returned. Entries must be postmarked no later than **Friday**, **Nov. 16**, **2018**.

The winning categories are:

- \$50 Award for one student from each grade who comes in 1st place. This artwork will be reproduced in the PLCB's annual calendar.
- \$50 Award for students with artwork to be reproduced as various PLCB materials such as folders, notebooks and coloring sheets.
- 3. \$25 Award for one student from each grade who comes in 2nd place.
- 4. Certificate of Recognition Award for one student from each grade who comes in 3rd place.

Winners will be contacted in early 2019 and will be recognized at a ceremony in Harrisburg in the Spring.
