SMALL BUSINESS ASSISTANCE GRANT PROGRAMS

- \$100 million for small businesses hurt by COVID-19 through the Main Street Businesses Revitalization Program for PA for-profit businesses with 25 or fewer employees.
- \$100 million for businesses owned and operated by socially and economically disadvantaged people through the Historically Disadvantaged Business Revitalization Program for PA for-profit businesses with 25 or fewer employees and which is owned, managed, and operated by those in socially & economically disadvantaged groups.

These grants of up to \$50,000 each can be used for operating costs.

Funding will be distributed through local Community Development Financial Institutions (CDFIs). Businesses will need to apply directly to one of 17 certified CDFIs serving Montgomery County:
