Dear Legislators and Staff of Erie County PA;

The Greater Erie Community Action Committee (GECAC) is announcing that the GECAC Erie County Area Agency on Aging will be distributing \$50 in vouchers for the purchase of Pennsylvania produce through the Senior Farmers Market Nutrition Program (SFMNP). The program is intended to encourage more seniors to incorporate fruit and vegetables into their diets. The vouchers were made possible by the Pennsylvania Department of Agriculture. GECAC is the designated provider of \$187,500 worth of fruits and vegetables to 3,750 Erie County seniors through this program.

To be eligible, a senior must be an Erie County resident, 60 years of age or older in 2023 and meet the income guidelines. Income eligibility is based on the total household income and on the number of people living in a household.

1 person - \$26,973	5 people - \$65,009
2 people - \$36,482	6 people - \$74,518
3 people - \$45,991	7 people - \$84,027
4 people - \$55,500	8 people - \$93,536

Eligible seniors may receive vouchers, **while supplies last**, through the community distribution events as listed below. Seniors are to go to the location closest to their home. Seniors are asked to show proof of age and residency (not income) at the distribution site (driver's license, PA ID, Birth Certificate, current utility bill other official mailing with address).

Eligible seniors may ONLY receive vouchers one time in the program year of 2023. This information will be verified when vouchers are received.

A Proxy Form must be <u>received in advance</u> of the date, be completed in full, and signed and brought to the distribution site. **Proof of age and address for the senior must be presented by the proxy, as well, the proxy will need to show their own ID**. Proxy forms may be accessed on the GECAC website, picked up from any of the GECAC Senior Centers, the Main GECAC Office, 18 W. 9th Street in Erie, or, they may be mailed upon request. **Proxy's may not proxy for more than four (4) seniors.** Call 459-4581, ext. 400 for more details if needed.
