#### Update on the Lawrence County racetrack and casino

The proposed casino and harness racing facility in Mahoning Township, which I strongly support, is back on track.

The long-awaited project has had more than its share of setbacks.

Originally, Indianapolis-based Centaur planned to build the facility, but ran into financial problems and auctioned the project to American Harness Tracks as part of a federal bankruptcy case.

Last fall, the Pennsylvania Harness Racing Commission approved the transfer of American Harness Tracks stock to Endeka Entertainment.

The project received some good news when Penn National Gaming, which owns and operates more than 20 horse racing and casino gaming facilities throughout the United States and Canada, announced a partnership with Endeka.

Penn National paid the \$50 million application fee to the Pennsylvania Gaming Control Board for the proposal, and is providing a \$15 million loan for the \$158.5 million project. Penn National also acquired the option to purchase a one-third ownership interest in the racetrack and casino.

The facility, which is proposed for a 250-acre site off Route 422, is expected to have about 1,250 slot machines at opening, 40 live table games, 10 poker tables, and parking for 2,000 vehicles. Most importantly, the project is expected to create about 1,200 full- and part-time jobs for our area.

Penn National and Endeka have applied for a license with the Pennsylvania Gaming Control Board. The board will review the application, conduct background checks and accept input regarding the project. Public hearings will be held in Mahoning Township.

This partnership between Endeka and Penn National is encouraging. I will be sure to keep you informed as the project moves forward.

#### Plan ahead. Be prepared.

#### COMING SOON: Veteran designation on Pa. driver's licenses

Pennsylvania recently enacted a law to provide veterans with a veterans designation on their Pennsylvania driver's license.

The governor signed legislation, which I co-sponsored, into law in October 2012. However, PennDOT has until June 2014 to make these licenses available to veterans.

The military generally only provides a veterans status identification card for those who have a "retired" designation, which requires 20 to 30 years of service. Many people today serve their country for several years, then go on to work in the private sector, leaving them only with their DD-214 or NGB-22 discharge papers to prove their status.

Once available, these licenses will provide an easy way for veterans to prove eligibility for benefits or discounts without having to carry their discharge papers.

To qualify, an applicant must have served in the United States Armed Forces, including a reserve unit or the

National Guard, and been discharged or released from such service under conditions other than dishonorable.

There will be no additional cost to veterans for the special designation on their licenses.

Numerous other states, including Arkansas, Connecticut, Florida, Indiana, Maine, Massachusetts, North Dakota, Oregon, Tennessee, Texas and Utah have enacted



### 2013-14 state budget highlights

A few hours before midnight on June 30, Gov. Tom Corbett signed the General Appropriations bill (Act 1A/HB 1437), providing \$28.375 billion in state fund expenditures for 2013-14.

Below are several highlights as they relate to veterans, emergency preparedness and public safety:

- An additional \$1.05 million, a 64.3 percent increase, for **Veterans' Outreach Services**.
- \$100,000 for the **Pennsylvania Civil Air Patrol**, which last received state funding in 2009-10.

The Civil Air Patrol is a federally supported, nonprofit organization serving as an official civil auxiliary arm of the United States Air Force. It consists of volunteers who support emergency service responders by conducting search-and-rescue operations, providing disaster relief and performing homeland security missions.

- Provides for three **State Police** cadet classes (approximately 290 cadets) and the hiring of 90 civilians to free up 90 troopers, for a total of 380 additional troopers. The State Police currently has 544 vacancies and about 1,000 troopers are eligible to retire.
- \$2.5 million to the Attorney General's Office to create a new Mobile Street Crimes Unit to fight gang activity.

Attorney General Kathleen Kane has said the unit will combine resources from the Federal Bureau of Investigation, the federal Drug Enforcement Agency, the Attorney General's Bureau of Narcotics Investigation & Drug Control, and local police departments.

Increases the Safe Schools Initiative by \$6.5 million, or 321.5 percent, for total funding of \$8.5 million. The funding provides targeted grants to schools and municipalities to address school violence and safety issues.

#### New law preserves 911 center funding

Legislation to restructure the E-911 Wireless Fund and ensure its viability into the future was signed on June 17 to become Act 9 of 2013. Without this law, the fund would have become bankrupt by 2014.

Funding for county 911 services is critical. Without the changes in this law, our 911 centers would have been in a perilous funding position. Act 9 authorizes the Pennsylvania Emergency Management Agency (PEMA) to provide counties with helpful suggestions to cut costs, including joint purchasing, regionalization and consolidation. The law also eliminates a 911 center's ability to "carry forward" unpaid PEMA approved costs. Currently, any 911 center request that is eligible for funding, but is not able to be funded in the current year, can be funded "off the top" of the following year's appropriation. If this practice was allowed to continue, these carryover IOUs would have functionally bankrupted the E-911 Wireless Fund by 2014.

After a one-year transition period, Act 9 eliminates the carryover provision, allowing 911 centers to apply for and receive funding for the current year and keep the E-911 Wireless Fund solvent and able to meet the needs of call centers on a yearly basis.

Additionally, the House Veterans Affairs and Emergency Preparedness Committee, of which I am the Democratic chairman, continues to work with PEMA and all other interested parties to update provisions of the law and further examine the funding formula and surcharge on devices used to call 911.

#### Honoring our service members' final wishes


Legislation to ensure that Pennsylvania respects the final wishes of our service members was recently signed into law. Act 45 recognizes the DD Form 93 as the formal mechanism for service members to determine who has the right to

Previously, state courts had to honor a will, even if it varied from a DD Form 93 that was executed at a later date. Act 45 will make it legally clear that these decisions should be determined according to the wishes of the person in military service as authorized on their DD Form 93. This will help in instances where a will has not been updated and family members, including current and former spouses, are in conflict over the decision.

Pennsylvania had been one of a few states that did not recognize the document as an acceptable form for military personnel.
