I left the Drug Abuse Resistance Education graduation ceremony at Morrisville Intermediate School impressed with both the students and the staff leading the program. D.A.R.E. provides children with the skills they need to avoid involvement in drugs, gangs and violence. So many people need to be applauded for their work, including Morrisville Borough Police Department Officer Chris Reardon, school Superintendent Jason Harris, Principal Lynn Palumbo and all the teachers – who have done a great job guiding our students.

Grant-funded computer training for seniors

After working with the Morrisville Senior Servicenter's board and officers, as well as current and former executive directors Clark Shuster and Scott Mitchell, I presented the senior center with a check for \$150,000 last summer. These funds represented a grant from the Pennsylvania Department of Human Services devoted to providing job training for seniors. The senior center is putting the grant money to good use through a free job training program to help seniors.

PennDOT to repave roads in Lower Makefield and Morrisville

PennDOT has announced the repair and resurfacing of 35 miles of state highways in Bucks County.

Among the roads in our area are:

Route 32 (Bridge Street/Delmorr Avenue/River Road) between U.S. 1 (Lincoln Highway) and Bedford Place in Lower Makefield and Falls townships, and Morrisville Borough.



Trenton Avenue between Woolston Drive/Lincoln Highway and Route 32 (Delmorr Avenue) in Falls Township and Morrisville Borough.

No start dates have been announced for the area roads, but I will update you when they become available.

PennDOT also has been working to repair potholes. If you see a pothole on a state road, please report it by calling 1-800-FIX-ROAD or submitting information to https://customercare.penndot.gov/.

And, be assured, I am continually advocating for PennDOT to resurface more roads in and around our district, which we know all too well need repair and improvement.



On a beautiful Saturday morning, I threw the ceremonial first softball pitch to launch the 2019 Morrisville Little League season. It was great to see the children of our community come together and enjoy America's favorite pastime!

LEGISLATIVE UPDATES

Here's a look at some bills I'm working on – and one that recently passed.

Ending child marriage:

The issue of child marriage was brought to my attention in 2017 by two constituents, including Newtown Borough Councilor Tara Grunde-McLaughlin. On June 5, the bill that would prohibit marriage before the age of 18 unanimously passed the House.

I served as the bill's co-prime sponsor with Rep. Jesse Topper, R-Bedford/Fulton/Franklin, and I'm gratified that my colleagues on both sides of the aisle saw that this bill is about child protection. Studies have shown that the child is not in control of a decision to marry before 18, and a child under 18 does not have the legal rights of an adult.

I hope my colleagues in the Senate think it is time to set the age at 18 to protect children in Pennsylvania.

The bill (H.B. 360) would repeal the current exceptions and set the minimum age at which a marriage license may be issued to 18.

Combating plastic pollution:

Plastic, single-use water bottles are cheap and accessible, however, their convenience does not outweigh their negative environmental impact. Only 25% of all disposed plastic bottles end up getting recycled throughout the country. This means the other 75% are susceptible to polluting our local roads and waterways. In 2017, plastic bottles accounted for nearly half of all the litter collected from the Delaware River.

Reusable water bottles are a simple and eco-friendly alternative to disposable plastic bottles. I introduced a bill that is part of the "Zero Waste PA" package, which would require state buildings to install water bottle filling stations. The easy access to these water stations would make the most eco-friendly option the most convenient, thereby reducing the use of plastic bottles and helping to clean up Bucks County.



Flood Insurance Premium Assistance Task Force:

While insurance is meant to serve as a homeowner's peace of mind, rising premiums on flood insurance can instead turn it into a financial burden. Higher premiums on flood insurance increase the overall cost of owning a home located in a flood plain.

To help all current and future homeowners, I introduced

legislation, House Bill 328, which would establish a Flood Insurance Premium Assistance Task Force. This task force would promote premium discounts and recommend programs that incentivize local governments to support flood mitigation efforts. This bill unanimously passed the House of Representatives and is on its way to the Senate.

Establishing our state-run health care exchange:

Governor Tom Wolf signed into law House Bill 3. The historic reform allows Pennsylvania to take steps to operate its own online health insurance exchange, like the one formerly managed by the federal government.

Pennsylvania will join about a dozen states that have built and operated their own exchanges. Our state is expected to have its state-based exchange up and running as soon as Jan. 1, 2021. The move is expected to save money for those purchasing plans on the exchange, and technological advances since the federal exchange opened in 2010 will allow Pennsylvania to run the exchange more efficiently.

Supported by Democratic and Republican leaders, the law will help reduce premiums for approximately 400,000 people who purchase health insurance through the marketplace.





Pre-existing conditions:

State Rep. Peter Schweyer, D-Lehigh, introduced a bill to prevent insurance companies from denying coverage or charging high premiums to people with pre-existing medical conditions, and I am a proud sponsor of the bill.

Pre-existing conditions, such as diabetes, asthma and pregnancy, are covered by health insurance because of safeguards written into federal law. If federal law changes, then millions of Pennsylvanians may be left without insurance coverage for these conditions. This bill would guarantee safeguards so that pre-existing conditions don't add a monetary burden or bankrupt a family who is just trying to get treatment.
