

# \$7.28 million reinvested throughout the district

For many years, I have worked to ensure that our area receives state resources for investments in projects that benefit our communities. These are your tax dollars and I'm glad to do my part to make sure they find their way back to Lackawanna County. I encourage community leaders and others to contact my office for more information about state grants, funding and programs that are available. The following is a breakdown of the funding distributed throughout our communities since I took office in November.

The Northeastern Pennsylvania Alliance was awarded \$4 million in Community Development Block Grant-CARES Act funding to provide grants of up to \$50,000 for small businesses and up to \$15,000 for microenterprises that have been severely impacted due to COVID-19.

Our volunteer and career fire and rescue companies across our commonwealth have been struggling over the last several years. Those struggles have been compounded with personal and business complications these last two years because of COVID-19 issues. The Fire Company and Emergency Medical Service Grant Program provides vital financial lifelines for our communities.

Funding was approved for the following local agencies:


- \$15,000 to the Scranton Fire Department.
- \$15,000 to the Chinchilla Hose Company of South Abington Township.
- \$8,325 to the Chinchilla Hose Company of South Abington Township (EMS).

The CFA Multimodal Transportation Fund provided the following grants:

- \$779,483 for streetscape improvements along Main Avenue from Oram Street north to the North Scranton Expressway and other related safety and disability-access sidewalk upgrades in Scranton.
- \$71,825 flood mitigation funding to repair a collapsed gabion basket in Scranton.
- \$40,222 for the construction of ADA-compliant walking trails within the Garden of Cedar pocket park located in Scranton.

The Department of Conservation and Natural Resources awarded Community Conservation Partnership Program grants for the following Scranton. projects:

■ \$2 million – for the construction of pool, spray park, bathhouse and



pavilion; installation of filtration and recirculation systems, utilities and fencing; ADA access, landscaping, project sign and other related site improvements at Nay Aug Park.

- ■\$198,000 for the renovation of pool building and parking areas; construction of pedestrian walkway, internal loop trail and stormwater management measures; installation of play equipment with required safety surfacing; ADA access, landscaping, project sign and other related site improvements at Weston Park.
- ■\$149,400 for the renovation of concession building; construction of dog park, pedestrian walkway, internal loop trail and stormwater management measures; installation of play equipment with required safety surfacing; ADA access, landscaping, project sign and other related site improvements at Connell Park.

#### Need help heating your home?

The Low-Income Home Energy Assistance Program helps families pay their heating bills in the form of a cash grant. Households in immediate danger of being without heat may also qualify for crisis grants.

The cash grant is a one-time payment sent directly to the utility company/ fuel provider to be credited on your bill. These grants, which do not have to be repaid, range from \$500 to \$1,500 based on household size, income, and fuel type.

Paper applications are available at the Lackawanna County Assistance Office, 200 Scranton State Office Building, 100 Lackawanna Ave. in Scranton. My office also can provide an application and help filling it out.

# Keeping hard liquor sales in state stores means more control and safety for you

I recently participated in a public hearing with our Liquor Control Committee in Harrisburg to discuss the desire by some private interest groups to abandon the current system of the sale of hard liquor in Pennsylvania.

I am a staunch supporter of the current system of hard liquor sales - not only because it generates hundreds of millions of dollars in profit for the commonwealth and provides over 5,000 local, familysustaining wage and benefits careers - but equally important is the neighborhood safety factor. Study after study has shown that the greater sales outlets that there are for hard liquor stores in neighborhoods - the greater the crime activity - and that includes robberies, stabbings, shootings, and sexual assaults. Our current system of hard liquor sales in our state stores is safe and secure and prevents illegal sales to minors.

### Apply now for Property Tax/Rent Rebate

The Property Tax/Rent Rebate Program is dedicated to helping eligible Pennsylvanians receive rebates for their property, whether they rent or own.

It's open to Pennsylvanians 65 or older; widows and widowers 50 or older; and people with disabilities 18 or older. The income limit is \$35,000 a year for homeowners and \$15,000 annually for renters, and half of Social Security income is excluded.

The maximum standard rebate is \$650, but supplemental rebates for qualifying homeowners can boost rebates to \$975

Claimants must reapply for rebates every year because they are based on annual income and property taxes or rent paid each year. Spouses, personal representatives or estates may file rebate claims on behalf of deceased claimants who lived at least one day in 2021 and meet all other eligibility criteria.

The state Department of Revenue is encouraging people to apply online by visiting mypath.pa.gov or by calling 1-888-222-9190. My office also can help you, so don't hesitate to contact us.



## Do you have unclaimed property?

The Pennsylvania Treasury holds \$3.8 billion in unclaimed property that needs to be returned to the rightful owners!

One in 10 Pennsylvanians has unclaimed property waiting for them. To find out if you are one of them visit www.patreasury.gov/unclaimed-property or call my office (570-342-4348) and we can help you search the database.

## Need help with water bills?

The Low-Income Household Water Assistance Program is available to help Pennsylvanians maintain access to drinking and wastewater service.

Assistance is available for families who have past due water bills, had their service terminated, or received a notice indicating that their service will be terminated in the next 60 days.

Households can receive LIHWAP grants for both drinking water service and wastewater service. Grants are issued directly to water service providers, and families must meet income requirements. As you prepare to apply have the following information ready to submit with your application:

- 1) Names, Social Security numbers, and dates of birth for all people in the household.
- Proof of income for the applicant and all household members.
- A recent water bill.

## Program helps homeowners

The Pennsylvania Homeowner Assistance Fund, or PAHAF, is a housing-related program funded by the U.S. Department of the Treasury to assist Pennsylvania homeowners facing financial hardship due to the COVID-19 pandemic that began after January 21, 2020, (including a hardship that began before January 21, 2020, and continued after that date).

The program provides financial assistance to homeowners for qualified mortgage and housing-related expenses to avoid delinquency, default, foreclosure or displacement.

### Affordable prescriptions for seniors



Older Pennsylvanians living on fixed incomes should never have to choose between affording medicine and affording food or rent or heat. Pennsylvania's prescription assistance programs for older adults, PACE and PACENET, offer low-cost prescription medication to qualified residents, age 65 or older.

Recently, the program was expanded to help 100,000 more of our wisest friends and neighbors qualify for PACENET by raising the income limits to \$33,500 for a single person and to \$41,500 for a married couple.
