I hope you and your families have had a safe, fun and enjoyable summer. It's been busy both in Harrisburg and here at home!

We recently passed a \$45.2 billion state budget for 2022-23 that will make many significant investments for Pennsylvanians. The spending plan includes historic investments in public schools, in both basic and special education, along with funding increases to boost school security. Additionally, the budget provides funding to improve access to child care, help residents with home repairs and expand affordable housing.

Enclosed in this newsletter, you will find details on state-related programs and services, how my office can assist you, what's been happening around our district and a special outdoors outlook for enthusiasts looking to enjoy Pennsylvania's natural beauty in the summer, fall and winter months. Property Tax/Rent Rebate Program

The deadline to apply for the 2021 Property Tax/Rent Rebate Program for rebates on property taxes or rent paid has been extended to December 31.

This rebate program benefits eligible Pennsylvanians 65 and older; widows and widowers 50 and older; and people with disabilities 18 and older.

Included in the new state budget, homeowners and renters who are already receiving aid through the Property Tax/Rent Rebate Program will receive an extra, one-time payment equivalent to 70% of their original rebate amount.

This will provide an additional hundreds of dollars a year for households.

If you already applied, you're all set. If you haven't applied, you can call my office at 610-266-1273 and my staff will gladly help you with your questions and the application process. You can also apply online at revenue.pa.gov/ptrr.

PA Treasury Unclaimed Property

It is estimated that one in 10 Pennsylvanians has unclaimed property. Every year, the Pennsylvania Treasury receives unclaimed property in the estimate of millions of dollars. Closed bank accounts, uncashed checks, contents of safe deposit boxes, and many more items can qualify as unclaimed property. My office has helped discover thousands of dollars for a resident that was returned to them by the Treasury.

To find any unclaimed property that you may have, you can search your name in a database at patreasury.gov or you can call my office at 610-266-1273 and somebody will search your name while you are on the phone.



Whole-Home Repair Program

Included in the budget is \$125 million to establish the Whole-Home Repair program. This program, under the Department of Community and Economic Development, will provide financial assistance to qualifying homeowners and small-scale landlords to help upgrade their properties by improving habitability, energy/water efficiency, winterization, and accessibility for those with disabilities.



WHOLE HOME REPAIRS

Awards funds to governmental and nonprofit entities to distribute to qualifying homeowners and landlords

Eligibility for Homeowners:

- ✓ Earning up to 80% of the area median income.
- ✓ Eligible for grant up to \$50K

Eligibility for Landlords:

- ✓ Own 5 properties or less.
- ✓ Eligible for loan up to \$50K with rent charging restrictions

Funds Must Address:

- ✶ Habitability concerns
- ✶ Energy or water efficiency improvements
- ✶ Accessibility for persons with disabilities

New 988 Number Direct Link to Crisis Support

Pennsylvanians now have a new, easier way to connect to behavioral or mental health crisis services. By dialing 988, callers will be directly connected to the National Suicide Prevention Lifeline. Lifeline services are available 24 hours a day, seven days a week for free.

If you need support for a suicidal, mental, behavioral health, and/or substance use crisis, call, text, or chat with 988. You can also call 988 on behalf of someone else. The existing Lifeline phone number (1-800-273-8255) will remain available.

Beware of License Sale Scams!

Anglers and hunters: Beware of third-party websites advertising hunting and fishing licenses.

Both the Game Commission and the Fish and Boat Commission have reported cases of consumers purchasing licenses from third-party vendors at extra fees – some as high as \$50 – and then never receiving them. Some websites even request the purchaser's Social Security number, setting the purchaser up for identity theft. Many scam sites are designed to mimic the branding of the state Game Commission or Fish and Boat Commission.

The best way to ensure that you receive a legitimate fishing or hunting license is by purchasing it directly from the commissions.

For fishing licenses, the Fish and Boat Commission will issue a printable, electronic version as soon as the purchase is made. For hunting licenses, consumers will receive an email from the commission, and licenses will be mailed to the purchaser within two weeks.

If you encounter a website that does not appear legitimate, contact the PFBC Fishing License Help Line at 877-707-4085 or PGC's license division at 717-787-2084.

Consumers who are victims of a fishing or hunting license scam should also notify the state Attorney General. Visit www.attorneygeneral.gov and click on the "Submit a complaint" link at the top of the page. Then, scroll down to the link on the right titled "Scams Form."



Chronic Wasting Disease Continues to Threaten PA Deer Population

Chronic Wasting Disease remains the most serious biological threat facing Pennsylvania's whitetail deer population. The disease was first found in Pennsylvania in captive deer in October 2012 and in wild whitetails in early 2013.

The Pennsylvania Game Commission is responsible for managing and combating this highly transmissible neurological disease that affects deer, elk, moose, and reindeer.

Most strategies focus on reducing deer populations, which is currently the only known way to address the spread of CWD.

When the commission discovers CWD in a herd, it creates a Disease Management Area and implements steps to isolate the disease. The commission manages outbreaks by banning movement of high-risk deer parts outside the DMA boundaries and by expanding hunting opportunities to remove CWD-positive deer from the landscape.

Hunters who harvest deer in any DMA must follow strict guidelines on the commission's website about how to clean, transport, and submit their deer for study. To learn more about the disease and the commission's efforts to combat it, visit www.pgc.pa.gov and enter "CWD" into the search bar.



Take These Steps to Repel Pests

Ticks pose a serious threat of Lyme disease, while mosquitoes in our region have tested positive for West Nile virus. Follow these tips from the Pennsylvania Department of Health to protect yourself from both pests:

1. Use Environmental Protection Agency (EPA)-registered insect repellents containing DEET, picaridin, IR3535, Oil of Lemon Eucalyptus (OLE), para-menthane-diol (PMD) or 2-undecanone.
2. Treat your clothing and gear with products containing 0.5% permethrin.
3. Wear clothes that cover arms and legs and tuck your pants into your socks.
4. Do a full-body tick check on yourself and your pets after spending time outside.
5. Shower within two hours after returning indoors.



If you receive a tick bite, monitor the area for symptoms of Lyme disease, and contact your doctor immediately if you develop symptoms, which can include a bulls-eye shaped rash (occurs in about 70%-80% of cases), fever, fatigue, headache, muscle aches, joint pain or other unexplained problems.



New State Parks on the Horizon

The new state budget includes \$56 million for the Department of Conservation and Natural Resources to add three new state parks. The locations of the new parks – which will be the first to be added since 2005 – have not yet been determined.

A portion of the funding will also be used to develop Pennsylvania's first park dedicated to the use of all-terrain vehicles and other motorized recreation vehicles.

Currently, the commonwealth has 121 state parks comprising over 295,000 acres. They include 7,000 campsites, 56 major recreation lakes, 10 marinas, 61 beaches, 17 swimming pools, and over 1,000 miles of trails.
