who have offered kind words of support as we become a family of three.





Do you need help with a state-related matter, but my Springfield office is too far from you? Stop by my mobile office hours in Media. I'll have staff at Borough Hall on the 2nd Tuesday of every month!

Grants Awarded to the District

Part of my job as your legislator is to ensure that we get our fair share of state funding. I'm happy to say that I recently helped bring home these grants, and I'm going to continue working to bring even more back to our community!

- ▶ Springfield Township: \$500,000 for indoor air quality HVAC replacement at the municipal building.
- ▶ Swarthmore Borough: \$200,000 for an ADA compliant sidewalk rehabilitation project.
- ▶ Upper Providence Township: \$424,500 to upgrade Ray Roche Park and strengthen ADA accessibility
- ▶ Marple Township: \$367,500 for the construction of a walking trail and park improvements in Veterans Park Trail, including stormwater management measures.
- ▶ Marple Township Police Department: \$268,150 for body cameras and dash cams.
- ▶ Upper Providence Police Department: \$49,602 for a new police cruiser.
- ▶ Broomall Fire Company: \$99,106 to purchase a utility vehicle equipped with a snowplow.
- ▶ Six local fire and EMS companies: \$103,089 to be used toward facility upgrades, equipment, debt reduction, training and certification, education and public outreach, and recruitment and/or retention efforts.
- ▶ Springfield Fire Company: \$50,000 to replace the Plymovent exhaust system inside the station. This system captures the trucks' exhaust emissions, ensuring clean air for the company's firefighters.
- ▶ Rose Tree Media School District: \$11,128 to purchase new food service equipment for cafeterias.

Recent Commonwealth Court Ruling on Education Funding

For too long, the Pennsylvania legislature has neglected our students by failing to properly fund our schools. A Commonwealth Court ruling from the William Penn School District v. Pennsylvania Department of Education case in February confirmed this. The ruling concluded that Pennsylvania underfunds some school districts so badly it violates the state constitution. Specifically, the judge held that:

- 1) Education is a fundamental right in Pennsylvania.
- 2) The Education Clause of the Pennsylvania Constitution was "clearly, palpably, and plainly violated because of a failure to provide all students with access to a comprehensive, effective, and contemporary system of public education that will give them a meaningful opportunity to succeed."
- 3) It is the legislature's, executive branch's and educators' responsibility to uphold the education clause and ensure that right is a reality throughout the commonwealth.

This was a historic decision by Commonwealth Court and affirms what we knew to be true: our current system for funding schools, which relies heavily on local property taxes tied to community wealth and wages, has been denying Pennsylvania students equal access to public education. While the judge's ruling lacked direction for the state legislature on just how much aid to distribute or how, she did indicate that it's up to the governor, lawmakers



and the school districts that sued to formulate a plan that addresses the constitutional violations.

Now that budget season is underway in Harrisburg, it's time for the legislature to create a funding system for our schools in which every student and every taxpayer is treated equally. With our new Democratic majority in the House, I'm ready to fight for equitable funding in Pennsylvania's public schools.

WORKING HARD IN HARRISBURG

Here's a glimpse of some legislative initiatives I'm currently working on in the state Capitol.

Extreme Risk Protection Orders

ERPOs, or "red flag" laws, temporarily disarm people in crisis to disrupt spontaneous acts of violence. Under current Pennsylvania law, the only intervention available for loved ones to keep family members in crisis safe is a 302 involuntary commitment. This approach deprives people of their liberty and holds them against their will without speaking with an attorney or judge. ERPO laws remedy this, by allowing for due process while ensuring that people who prove to be an immediate threat to themselves or others cannot possess or access firearms and ammunition for no more than one year. Data shows that ERPOs, when enacted, can also prevent mass shootings. In California, 21 orders were issued for individuals planning to commit a mass shooting from 2016-2018.

Early Voting

To cut down on long wait times at the polls and ensure those who work on elections can cast their ballots, my bill would permit Pennsylvanians to vote up to 30 days before an election. Early voting would take place at the county board of elections office and at designated polling places chosen by the county board.

Implementing Statewide Energy Efficiency Standards

Former state Rep. Wendi Thomas, R-Bucks, and I drafted legislation that would set energy efficiency and water conservation standards for commercial and residential appliances sold in the commonwealth. This would significantly help conserve water and reduce air pollution while saving millions of dollars every year. Plus, it would pose no inconveniences on Pennsylvanians' day-to-day lives.

Hospital Closure Reform

This legislation I introduced with Rep. Eddie Day Pashinski, D-Luzerne, would reform our state's hospital closure process, increasing transparency and accountability every step of the way without disrupting access to care. Our bill would double the currently required 90-day notice of a hospital closure to 180 days. Our bill also bolsters community members' voices by requiring public hearings, gathering of relative and sufficient data, and providing for public comment prior to any closure.

Join the National Counseling Compact

The National Counseling Compact consists of 17 member states that allow mental health professionals to practice within its multi-state network without needing multiple licenses. By enrolling our commonwealth in this compact, we can mitigate the long wait times that patients experience for mental health care and increase accessibility. This could be done by utilizing telehealth and expanding care options for Pennsylvanians who live near one of our six bordering states.

Co-Chairing the Mental Health Caucus

It's my honor to be a chairperson for the bipartisan Mental Health Caucus. This is a group of legislators coming together across party lines to discuss how we can strengthen access to mental health services, reduce its stigma and connect with all Pennsylvanians to hear their perspective on issues that contribute to mental health concerns – from students to first responders. As a suicide loss survivor, mental health is an issue deeply important to me and has been one of my top priorities since taking office. I look forward to continuing and leading the work of the Mental Health Caucus and working from a legislative standpoint to ensure that Pennsylvania's health care system works for everyone.

REAL ID Update

The Department of Homeland Security announced that REAL ID enforcement will not go into effect until May 2025. This means that the previous deadline (spring of this year) requiring airline passengers to have a REAL ID or passport to fly domestically is postponed.

If you are still planning to get REAL ID, my office is available to help you get the necessary state documents. Feel free to reach out if you have any questions about the application process.

Delco in the White House

In December, it was my honor to represent Pennsylvania at the White House for a roundtable discussion. The theme was public policy that we can pass in state legislatures that directly supports American working families. I gained so much valuable insight and new perspectives on matters ranging from gender equity and the affordability of childcare to workplace discrimination and paid family leave.

I spoke about three bills I've introduced (and plan to re-introduce) – insurance coverage for infertility treatments, paid sick leave and updating our state's equal pay law. This whole discussion revolved around how we can make people's working lives easier and less stressful. After this experience connecting with lawmakers from all over the country and people from the Biden administration, I left feeling more inspired and motivated than ever for the 2023-24 legislative session and the work I do for you and working families across Delco.
