

## THIS SESSION'S LEGISLATION

You can go to www.RepMikeSturla.com and click on "Bills I've Introduced" under the "News" tab to see Rep. Sturla's legislation so far this session. His notable bills include:

HB 20 – Would provide \$350 million annually for projects to improve water quality.

HB 677 – Would enable municipalities to require fences between livestock and streams.

HB 679 – Would require all counties to have their own health departments or be part of a regional health department.

HB 680 – Would allow state grants per firehouse instead of per fire company.

HB 684 – Would require municipalities relying on state police for part-time or full-time coverage to pay a fee that covers the cost of a small portion of those services.

#### STURLA SERVING ON BASIC EDUCATION FUNDING COMMISSION

With the Commonwealth Court ruling that the state's school funding formula is unconstitutional, Rep. Sturla will be very active this session in working with fellow legislators to devise a fair and equitable funding formula. Sturla has been on the Basic Education Funding Commission since its creation in 2015 where he has advocated for an improved formula and looks forward to discussing this important issue.

## OVER \$2.3 MILLION FOR LOCAL PROJECTS

Rep. Sturla recently helped secure state funding for local multimodal and public improvement projects via the Commonwealth Financing Authority:

- \$1,000,000 for YWCA Lancaster to construct and install an ADA-compliant, stretcher-sized elevator.
- \$200,000 to the City of Lancaster to construct an eastbound bicycle lane on Fulton Street in Lancaster City.
- \$250,000 for Tenfold to complete a comprehensive renovation to its 112-yearold TLC shelter facility that will provide better temporary housing and supportive services for people experiencing homelessness.
- \$476,905 for SACA Development Corporation to complete building renovations to their human services facility, El Centro Hispano.
- \$400,000 for South Ann Concerned Neighbors to construct a community hub where all neighborhood individuals are provided community resources.



#### NEED A SEPTA SENIOR FARE CARD?

You can call Rep. Sturla's office at 717-295-3157 to schedule an appointment to complete your SEPTA Senior Fare Card application. Please note that you will NOT receive your card the same day, and the anticipated processing time is five weeks. You also will need to bring your PA ID/driver's license or birth certificate. If renewing, please bring your expired card.

#### HELP WITH PROPERTY TAX/RENT REBATE PROGRAM

You have until June 30 to submit your Property Tax/Rent Rebate application for taxes/rent paid in 2022. You can apply at mypath.pa.gov or contact Rep. Sturla's office for assistance at 717-295-3157, especially if you have eligibility questions.

The following documents can be dropped off in the office's black mailbox (pictured here) in an envelope with your full name and phone number:

- Proof of income for 2022 (for example: if you work: W-2 or tax return; if you do not work, your letter from Social Security showing how much you received in disability payments or SSI payments).
- If you rent, your rent certificate signed by your landlord.
- If you do not rent, proof that you paid your property taxes to Lancaster County, your municipality, and your school district. This may be on your year-end mortgage summary (SS Form 1098) from your bank or mortgage company.
- Proof of identity (if this is the first time our office has helped you). Bank routing and account number (if you want the refund via direct deposit).
- Once these documents are received, Rep. Sturla's staff will call you to verify receiving them. Original documents will be mailed back to you.
