### **Happenings in Harrisburg**

The House Children & Youth Committee has hosted informational meetings on childcare and childhood nutrition and hosted a public hearing to discuss the overcrowding of juvenile detention centers.

### Challenges with Childcare

in Pennsylvania. The first informational meeting was held on Wednesday, March 29, 2023, to discuss the challenges with childcare in Pennsylvania. During the meeting, members heard firsthand of the experiences of childcare providers, the importance of childcare, and the impact of childcare on businesses and the workforce throughout the Commonwealth. The speakers included: Leslie Spina, Executive Director, Kinder Academy, Inc., Philadelphia; Diane Barber, Executive Director, Pennsylvania Child Care Association (PACCA); Jennifer Byrne, Owner of Spring Rose Childcare, Berks County; Shante Brown, Deputy Secretary, Pennsylvania Department of Human Services, Office of Child Development and Early Learning (OCDEL); Kimberly Early, Senior Director of Public Policy and Advocacy, Pennsylvania Association for the Education of Young Children (PennAEYC); Angela Ferritto,





President, The Pennsylvania AFL-CIO; Alex Harper, Vice President of Government Affairs, PA Chamber of Business and Industry; and Laura Manion, President and CEO, Chester County Chamber of Business and Industry (CCCBI). Ms. Manion shared that the lack of available childcare has overwhelmingly impacted the number of women returning to the workforce. All the panelists underscored how the childcare industry is critical to our economy and getting Pennsylvanians back to work.







### **Childhood Nutrition and School Meals.**

The second informational meeting was a joint meeting between the House Children & Youth Committee and the House Education Committee, held on Thursday, March 30, 2023, to discuss the Importance of Childhood Nutrition and School Meals. Members heard from their colleague, Rep. Emily Kinkead, who represents the 20th Legislative District, Allegheny County; Sally Zubairu Cofield, Director, Department of Health, Bureau of Women, Infants and Children (WIC); Dr. Amaka Nnanmani, MD, FAAP, and former General Counsel, Community Legal Services, Philadelphia, and Children First PA; Nicole Melia, Public Policy and Legislative Chair, School Nutrition Association of Pennsylvania (SNAPA); and Shea Saman, Chief Financial Officer, Feeding Pennsylvania. Rep. Kinkead discussed legislation she introduced, House Bill 180, which would require that breakfast and lunch is served every school day to every student attending a Pennsylvania elementary, middle, or high school, who wants one, regardless of income, by establishing a permanent universal school meals program. This joint informational meeting was helpful in ensuring that members understood the critical need to address childhood nutrition to improve behavioral and health outcomes for children.

Juvenile Detention Centers. A public hearing was held on Thursday, April 20, 2023, to discuss the Overcrowding of Pennsylvania's Juvenile Detention Facilities. During the hearing, committee members received an overview of the juvenile justice system and learned of relevant data, including recidivism rates, high risk juveniles, and capacity limitations related to juvenile detention centers. The speakers included: Laval Miller-Wilson, Deputy Secretary, Pennsylvania Department of Human Services Office of Children, Youth and Families; Chadwick Libby, Dauphin County Director of Probation Services, and the Current President of the Pennsylvania Council of Chief Juvenile Probation Officers; Kimberly Ali, Commissioner, Department of Human Services, City of Philadelphia; Malik Pickett, Esq., Staff Attorney, Juvenile Law Center; and Bryanna Hood, Advocate, Juvenile Law Center. The information shared during the hearing was helpful in educating members on the issue of juvenile detention facilities in Pennsylvania. Pickett provided an overview of detention and residential placement facilities, the issue of overcrowding, and the removal of youth from detention facilities.

### **Voting Meeting**

The House Children & Youth Committee hosted its first voting meeting of the current legislative session on Tuesday, May 2, 2023. The Committee members met to consider two bills and one resolution.

House Bill 664, sponsored by Chair Bullock, establishes a Women's Infant, and Child (WIC) Advisory Board within the PA Department of Health.

There were two amendments offered to the bill.

Minority Chair Barry Jozwiak sponsored Amendment A00366, which established security measures to protect WIC participants' personal information and prevent fraudulent activity in the use of WIC benefits.

Chair Bullock sponsored Amendment A00412, which amended the bill by adding additional WIC topics the board can offer advisement on including increasing awareness and support of WIC breastfeeding services for WIC breastfeeding experts and noting that one of the two medical professionals is a pediatric physician. House Bill 664 as amended passed nearly unanimously with a vote of 20-1.

Finally, the Committee considered one resolution, House Resolution 91, sponsored by Rep. Mike Schlossberg. House Resolution 91 designates May 7-May 13, 2023, as, "Jewish Day Schools Week," in Pennsylvania. House Resolution 91 was reported from Committee unanimously.

















### **Children & Youth Facts:**

Childcare staffing shortages across the Commonwealth have resulted in a lapse of services, while economically burdening families. As a result of the staffing shortages, more than 35,500 children remain on a waitlist for childcare. The lack of childcare staff has detrimentally impacted families, employers, and taxpayers resulting in \$6.65 billion lost annually in wages and revenue.

Chair Bullock looks forward to working with the Committee and stakeholders to advance the Committee's ongoing priorities and new policy issues, such as childhood nutrition and services for unhoused children and youth and children who are involved in the criminal justice system.

#### House Bill 664 (Chair Bullock)

- Establishes a WIC Advisory Board within the PA Department of Health.
  House Bill 664 was reported as amended from the House Children & Youth Committee on Tuesday, May 2, 2023 (20-1).
  - House Bill 664 was voted out of the House of Representatives
  - on Wednesday, June 12, 2023 (155-48).

#### House Resolution 91 (Rep. Schlossberg)

- Designates May 7-May 13, 2023, as "Jewish Day Schools Week" in Pennsylvania.
  - House Resolution 91 was reported as committed from the House Children & Youth Committee on Tuesday, May 2, 2023 (21-0).
  - House Resolution 91 was adopted by the House of
    - Representatives on Monday, May 22, 2023 (201-0).

## **House Children & Youth Committee**

### **Bills & Resolutions for the 2023-2024 Legislative Session**

#### House Bill 665 (Chair Bullock)

- Amends Act 121 of 1986, the Women's, Infants', and Children's Nutrition Act by clarifying the eligibility of WIC participants, allowing a person to submit eligibility documentation online to a WIC agency before meeting to confirm their enrollment.
  - House Bill 665 was reported as amended from the House Children & Youth Committee on Wednesday, June 7, 2023 (20-1).
  - House Bill 665 was voted out of the House of Representatives on Thursday, June 22, 2023 (176-27).

#### House Bill 1058 (Rep. Krajewski)

- Amends Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes by adding language requiring the court to solicit and consider the opinions of those who engaged with the family finding and kinship care programs before and during child custody proceedings.
  - House Bill 1058 was reported as amended from the House Children & Youth Committee on Wednesday, June 7, 2023 (21-0).
  - House Bill 1058 was voted out of the House of Representatives on Thursday, June 22, 2023 (203-0).

#### House Bill 1020 (Mehaffie)

- Amends Article IX Department Powers and Duties as to Supervision and Article X Department Powers and Duties as to Licensing of the Human Services Code by adding language to codify the Keystone STARS Program, while allowing for varied work experiences, professional development, effective leadership, and program management as staff qualifications for all certified childcare providers to move up a STAR level in the Keystone STARS Program, and allowing each certified childcare provider in the Keystone STARS Program to display its designated STAR-level rating on its public website, the Department of Human Services' website and on a DHS-issued placard in a public-facing location.
  - House Bill 1020 was reported from the House Children & Youth Committee on Wednesday, June 7, 2023 (19-1).
  - House Bill 1020 was voted out of the House of Representatives on Monday, June 26, 2023(151-52).

#### House Resolution 126 (Kinsey)

- Designates the month of May 2023, as "Foster Care Month" in Pennsylvania.
  - House Resolution 126 was reported as committed from the House Children & Youth Committee on Wednesday, June 7, 2023 (21-0).
