

#### IT'S BEEN A BUSY FEW MONTHS AND I'VE BEEN WORKING HARD FOR YOU BOTH IN HARRISBURG AND HERE AROUND HOME!

I serve on five PA House committees: Aging & Older Adult Services, Commerce, Housing and Community Development, Liquor Control, and recently I was appointed to the Veterans Affairs & Emergency Preparedness Committee.

I look forward to working with our state's veterans in 2024 to ensure that we are taking care of the men and women who fight tirelessly for our rights and freedoms.

My fellow House Democrats and I are fighting to uplift all Philly schools and students across Pennsylvania. Our work on the 2023-24 state budget allowed us to make historic investments in K-12 public schools, including a \$567 million increase in Basic Education Funding and a \$46.5 million increase to provide universal free breakfast for public school students.

Also, we allotted an extra \$175 million to fix school infrastructure. Too many times I have heard parents' concerns over the conditions of our public schools, so I was proud to vote yes on this funding, which will ensure our students aren't learning in unsafe and uncomfortable environments.



PA House Democrats also fought hard to give Pennsylvanians a raise in the minimum wage. Our legislation passed the House but remains blocked in the GOP controlled Senate. Scan the QR code to tell your state Senator to Raise the Wage in PA.

Balancing life between working and raising a family is demanding, especially when you have to figure out how to pay for childcare. Pennsylvania parents will see a dramatic increase in their Child and Dependent Care Tax Credit due to House Democrats fighting to ease the burden for working families.

#### KEEPING PENNSYLVANIA HEALTHY AT LOWER COSTS

Pennsylvania's prescription assistance programs for older adults, PACE and PACENET, offer lowcost prescription medication to qualified residents, age 65 and older. The program works with Medicare Part D plans and other prescription drug plans such as retiree/union coverage, employer plans, Medicare Advantage (HMO, PPO) and Veterans' Benefits (VA) to lower out-of-pocket costs for medications.

#### COME GET YOUR SEPTA SENIOR FARE CARD

Older adults with a valid Senior Fare Card ride free at all times on all types of SEPTA routes! If you are 65+ years old and need a new card or renewal, please reach out to our office for an appointment. Applicants need to bring a valid ID and be ready to have their picture taken.

#### Need Energy Assistance? 2023-2024 LIHEAP Applications are Now Open!

The Low Income Home Energy Assistance Program (LIHEAP) is accepting applications! LIHEAP helps lowincome families pay their utility bills with a cash grant paid directly to the energy provider. There are two ways to apply for LIHEAP:

**Online:** Apply for benefits online using COMPASS, the online tool for Pennsylvanians to apply for health and human service programs and manage benefit information.

**On paper:** You can download a paper application, print it, fill it out, and return it to your local county assistance office. For assistance with filing out a paper application, contact my office to schedule an appointment.



#### ENDING MEDICAL CO-PAYS FOR INCARCERATED INDIVIDUALS

When individuals who are incarcerated are paid a starting rate of 19 cents per hour, they regularly face difficult financial decisions during incarceration. The choice they are often forced to face is whether they should spend \$5 on a copay to receive basic healthcare services or on other necessities, such as food, phone/ email costs or undergarments.

Not only does the \$5 copay pose a financial burden to those incarcerated, but it also presents a public health dilemma by discouraging sick individuals from getting needed care. While incarcerated people still receive medical care if they cannot pay the copay, their account balance goes into the negative, often requiring additional payments from family members to pay off the balance.

Ending medical co-pays for our people who are incarcerated is an essential measure to ensure equitable access to healthcare, recognizing the right to comprehensive medical services for incarcerated individuals and promoting their well-being without imposing financial barriers.

#### EXPANDING CLEAN SLATE LAW

Sealing records helps save lives. When a person has a criminal record, it prohibits them from accessing benefits such as education, a career and even housing.

This creates a perpetual cycle of recidivism that would be avoided if a person let out of prison wasn't labled a criminal for the rest of their lives. It leaves people with a chance to serve their time and then be productive members of society. Someone with a misdemeanor or low-level felony shouldn't be defined by one instance.

This not only benefits those directly affected but also contributes to a more just and inclusive society. Clean Slate 3.0 was signed into law in December.

In addition to Clean Slate, I joined the fight to fund indigent defense because Pennsylvania was one of only two states that didn't provide funding for it. Now, with House Democrats in the Majority, we have allotted \$7.5 million to provide legal services to those who can't afford it. Every Pennsylvanian has the right to legal representation regardless of financial circumstances.

#### **DIGNITY FOR INCARCERATED WOMEN**

Pregnancy can be an incredibly scary time for a woman, even more so for incarcerated women. These women deserve to be treated with compassion and common decency to ensure their health and the health of their child.

We should strive to make sure that our correctional officers who interact with pregnant women are trauma informed, because giving birth and the post-partum stage can be unimaginably traumatic.

They should never be shackled, or their movement restricted for not only the sake of their dignity but because it can be harmful for both the mother and child.

Sending pregnant women to solitary confinement can have serious and harmful consequences for both the expectant mother and her unborn child. It takes a serious toll on a woman's mental health, which is hard to break out of and will affect her developing fetus.

I'm proud to work with colleagues like state Rep. Morgan Cephas, a fellow Philly state representative, who advocated for this important legislation, and I will always vote yes to protect the dignity of all women.

#### **MATERNAL MORBIDITY**

Maternal morbidity is a significant public health concern. It refers to the health complications experienced by pregnant women during pregnancy and childbirth which impact the health of women.

Common examples of maternal morbidity include gestational diabetes, hypertensive disorders (such as preeclampsia), postpartum hemorrhage, infections, mental health disorders (such as postpartum depression), and complications related to Cesarean section or other medical interventions.

The step to addressing this growing public health crisis is to record accurate data when the event occurs. That's why I voted yes to have Maternal Morbidity added to the list of reportable events within the PA Department of Health.

#### PROTECTING ABORTION ACCESS IN PENNSYLVANIA

Fifty-one years ago the U.S. Supreme Court ruled women have the right to control their own bodies. Nineteen months ago, a very different U.S. Supreme Court said it was up to the states, and now abortion is illegal or restricted in 21 states – but not in Pennsylvania.



PA House Democrats voted to pass HB 1786 which

would help to ensure that any person who needs an abortion can access that care in Pennsylvania safely and legally, without fear of retribution from law enforcement that they will be penalized for seeking that legal care.

It is essential to safeguard and preserve the right to choose, providing women with the autonomy to make decisions that align with their individual circumstances, health, and futures.



#### DENTAL SCREENINGS BY DENTAL HYGIENISTS

Regular dental check-ups for children play a vital role in preventing tooth decay, establishing good habits, and boosting confidence. Unfortunately, school districts often encounter difficulties trying to hire dentists. This legislation provides for more flexibility by allowing school districts to hire dental hygienist to ensure students have regular access to dental checkups.





#### PROPERTY TAX/RENT REBATE PROGRAM EXPANDED

Applications are now open for the Property Tax/Rent Rebate Program! The program provides income-eligible senior citizens and people with permanent disabilities a rebate on the property taxes or rent they paid in the previous year.

I'm pleased to report the program is now expanded in 2024 to include more people in our community, thanks to legislation I helped pass into law in June. The new law raises the income eligibility limit for both homeowners and renters to \$45,000 and raises the maximum rebate to \$1,000, allowing more folks to stay in their homes and afford their basic necessities. In Philadelphia, there are supplemental rebates available for those in need the most.
