
As your state representative for the 24th Legislative District, I continue to advocate for Pittsburgh's residents.

Since I began my term in January 2023, I've helped deliver more than \$24.35 million to support projects in Pittsburgh, launched the Pennsylvania Black Maternal Health Caucus and I serve as its co-chair with state Reps. Morgan Cephas and Gina Curry, have advanced reproductive health rights and access, equal justice for all, and so much more.

In my first few weeks of this year, I secured an additional \$1.22 million for important projects across the district including affordable housing in Homewood, improvements to the Latino Community Center and redevelopment in Larimer. These are projects that invest in Pittsburgh's economy.

LOOKING BACK ON 2023 AND LOOKING FORWARD TO 2024

With the assistance of my staff, I began to serve the 24th Legislative District by:

- Providing more than 11,000 state-related services to constituents.
- Co-sponsoring 131 bills and prime-sponsoring 3 bills.
- Passing 1 bill the CROWN Act (H.B. 1394) to prohibit race-based discrimination based on hair type, hair texture or hair style.
- Hosting community-based events, which 949 residents attended.
- Bringing back more than \$24.35 million to date in funding to serve area residents.

Thanks to the work of my District Office staff in Pittsburgh – Twanda Carlisle, my district office director, and Ricardo Worthey and Gloria Coulverson, my constituent service advisors, and Kim Davis, my legislative assistant in Harrisburg – we accomplished all of this work and more! In 2024, my staff and I look forward to continuing to provide even more high-quality constituent services to Pittsburgh residents.

WORKING IN HARRISBURG



Launching the Black Maternal Health Caucus

In 2023, I launched the Black Maternal Health Caucus with state Rep. Morgan Cephas and state Rep. Gina Curry. Together, we serve as co-chairs of the caucus and we work together to address the disturbing trends of Black maternal mortality and morbidity through bold legislative action, such as the Pennsylvania MOMNIBUS, a groundbreaking legislative package which would make significant investments to improve maternal health outcomes in Pennsylvania.

Collecting Data on Maternal Morbidity to Address Maternal Health

After we began our work within the caucus, Gov. Josh Shapiro signed Act 5 of 2023, also known as S.B. 262, sponsored by state Sen. Judy Schwank, D-Berks, into law that originated as H.B. 1362 sponsored by state Rep. Morgan Cephas. Act 5 requires the Pennsylvania Department of Health to report maternal morbidity data using hospital discharge data from the Pennsylvania Health Care Cost Containment Council. It also requires an annual report from the Maternal Mortality Review Committee to include data on maternal morbidity - this report was previously released every few years. As an advocate for Black maternal health and reproductive health, rights. and justice, chair of the Joint Committee on Women and Girls of Color of the





Pennsylvania Legislative Black Caucus and Women's Health Caucus, and co-chair of the Pennsylvania Black Maternal Health Caucus, I am thankful for Sen. Schwank's leadership, as well as Rep. Cephas for introducing the House version of this bill and Gov. Shapiro for signing the bill into law. This law will provide us with the data to improve maternal health for Pennsylvanians and further help the Black Maternal Health Caucus address Black maternal health care.

GRANTS AWARDED TO THE 24TH DISTRICT

To date, I worked to secure more than \$24.35 million in funding including:



- \$13.7 million to Pittsburgh Water and Sewer Authority to replace lead service lines.
- \$2.1 million to Pennley Commons Recapitalization for preservation.
- \$1.8 million to the Bloomfield Bridge to improve infrastructure.
- \$1.3 million to the city of Pittsburgh for new signal controllers and updates to signal equipment.
- \$1.1 million to the Larimer-Homewood Multimodal Greenway Extension for pedestrian and streetscape improvements.
- \$900,000 to African Queens Apartments for construction.
- \$500,000 to the city of Pittsburgh to redevelop the corner of Broad Street and Highland Avenue in East Liberty.
- \$500,000 to the Zoological Society of Pittsburgh to repair the Water's Edge Exhibit.
- \$398,000 to Three Rivers Youth to expand substance use disorder services.
- \$380,000 to Operation Better Block for affordable housing programs and neighborhood assistance.

- \$276,000 to Macedonia F.A.C.E. to expand substance use disorder services.
- \$258,000 to the Latin American Cultural Union to improve infrastructure.
- \$250,000 to New Granada Development for job training.
- \$231,000 to the city of Pittsburgh to construct green stormwater infrastructure.
- \$160,000 to Bloomfield-Garfield Corp. for affordable housing programs and neighborhood assistance.
- \$125,000 to Bloomfield-Garfield Corp. to restore the exterior parapet of the Negley Rotunda to prevent water from leaking into the building.
- \$100,000 to Latino Community Center to renovate its first floor.
- \$100,000 to Rodef Shalom Congregation to replace the roof.
- \$100,000 to the Urban Redevelopment Authority to renovate 501 Larimer St. and relocate the lottery store to 25 Meadow St.
- \$100,000 to Vintage Center for Active Adults to support senior services.

Recognizing Maternal Health Awareness Day in Pennsylvania

The PA Black Maternal Health Caucus uplifted Maternal Health Awareness Day on Jan. 23 with events, activities, and recognitions across the commonwealth. The Caucus co-chairs introduced H.R. 287 to recognize Maternal Health Awareness Day in Pennsylvania and hosted a screening of the film "Aftershock" produced by filmmakers Tonya Lewis Lee and Paula Eiselt at the Pennsylvania State Museum. This event was organized in partnership with the Governor's Commissions on African American Affairs and Women.

Making Donor Breast Milk More Accessible

I spoke with Second Lady Blayre
Davis and my colleagues in both the
House and Senate at the Mid-Atlantic
Milk Bank in Pittsburgh to celebrate
the signing of Act 32 of 2023, also
known as S.B. 500. I spoke about
the importance and challenges
of breastfeeding for moms and
postpartum parents and how, for sick
babies who need a specific type of
breastmilk, we are going to change
lives by expanding coverage of human
donor breastmilk through Medicaid.

- \$36,466 to Kelly Strayhorn Theater for programs and marketing.
- \$35,000 to Center of Life to develop the facility.
- \$27,500 to Kingsley Association for community services.

- \$27,186 to Legacy Arts Project for operations.
- \$23,000 to the Soldiers & Sailors Memorial Hall & Museum for operations.
- \$21,180 to Union Project for operations and marketing.
- \$20,000 to No Hero Left Behind to support services to veterans.
- \$20,000 to Pittsburghers for Public Transit based in Garfield for educating low-income residents about the Pittsburgh Regional Transit Discount Bus Fare program.
- \$20,000 to YWCA of Greater Pittsburgh to expand access to early childhood education.
- \$18,750 to Negley Commons for community services.
- \$10,948 to Autumn House Press for operations.
- \$10,000 to Balafon West African Dance Ensemble for programs and marketing.
- \$10,000 to Guardians of Sound for general operations.

With this funding, we will improve Pittsburgh, making it better for all residents through investments in housing, infrastructure, substance use disorder services, job training, senior services, education, urban agriculture, veteran services, and so many more community services.





Working to Recognize Maternal Health Awareness Day in Pittsburgh

I participated in the local honoring of Maternal Health Awareness Day, and I received a proclamation from Pittsburgh City Council introduced by City Council Member Barb Warwick. Council Member Warwick also introduced a Will of Council calling on the Pennsylvania General Assembly and Congress to pass any legislation that would advance maternal health measures and address race-based maternal health outcomes and disparities. I was happy to offer remarks and call on my colleagues in City Council to work together on Black maternal health specifically so we can stop the 92% of preventable maternal deaths in our commonwealth. Thank you to the many organizations and Black maternal health agencies that joined us in City Council, especially Healthy Start Pittsburgh, which is a long-time partner from previous work leading New Voices for Reproductive Justice.

Abortion Access in Pennsylvania

I began serving as the state representative for the 24th District to fight for reproductive justice and ensure abortion access in Pennsylvania. While the U.S. Supreme Court advanced its right-wing agenda by overturning Roe v. Wade in Dobbs v. Jackson Women's Health Organization



in June 2022, the PA House of Representatives took a stance to advocate for reproductive health, rights, and justice. In late 2023, the House focused on two bills, which would:

- Prohibit states from using the resources of Pennsylvania's legal system to
 prosecute people in civil and criminal lawsuits from other states if they access
 reproductive health care services in the commonwealth.
 - o The House passed H.B. 1786, sponsored by state Rep. Mary Jo Daley, D-Montgomery. It now awaits a vote in the Senate.
- Propose an amendment to the Constitution of the Commonwealth of Pennsylvania to provide for access to reproductive health care in Pennsylvania, thereby enshrining access to abortion into law.
 - o I testified before the House Judiciary Committee, of which I am a member, and our committee reported H.B. 1888, sponsored by state Rep. Danielle Friel Otten, D-Chester, out of committee. It awaits a vote in the House.

With these two bills, we have the opportunity to protect abortion access, as well as reproductive health, rights, and justice in our commonwealth.

Passing the CROWN Act

As a Black woman, I faced discrimination for my hair, which is why Speaker of the House Joanna McClinton, D-Phila., and I introduced the CROWN Act, or H.B. 1394, which would prohibit race-based discrimination based on hair type, hair texture, or hair style.

Together, we worked to pass the CROWN Act in the House by a vote of 182-21 in July, but the Senate has yet to consider the bill. This bill is currently in the Senate State Government Committee and is awaiting consideration.

about investing in our

state grants, as well as



state services such as the Property Tax/Rent Rebate Program, the state's health insurance marketplace, Pennie, and county services such as Pittsburgh Regional Transit's Senior Citizen ConnectCard.



I hosted my first town hall focused on health insurance, where I spoke to constituents about the state health insurance marketplace, known as Pennie, as well as my work in Harrisburg to increase healthcare access for all Pennsylvanians.









My district office staff joined local legal and prisoners' rights organizations to host a Pathways to Pardon: Re-Entry Resource Fair to provide resources on pardons and expungements to assist formerly incarcerated Pennsylvanians with re-entry into society and the Greater Pittsburgh community.

Apply for the Property Tax/Rent Rebate Program

Thanks to Act 7 of 2023, we expanded the Property Tax/Rent Rebate Program to allow 42% more residents in our community to benefit. In 2024, Pennsylvanians 65 and older, widows and widowers 50 and older, and people with disabilities with an income of \$45,000 or less are eligible for a rebate. Apply for Pittsburgh Regional Transit's Senior Citizen ConnectCard

Allegheny County residents 65 or older qualify for Pittsburgh Regional Transit's Senior Citizen ConnectCard, which allows seniors to ride public transit vehicles for free across Pennsylvania. Child and Dependent Care Tax Credit

We tripled Pennsylvania's Child and Dependent Care Enhancement Tax Credit to help working families pay for affordable child and dependent care. Now, when working families file their taxes, they may receive a state tax credit equal to 100% of the federal credit for child and dependent care, alleviating one of the biggest burdens on working families.
