## **KOSIEROWSKI VOTES FOR** PATIENT SAFETY

I am proud to be a prime cosponsor of legislation that



would protect the safety of patients by requiring minimum nurse staffing levels at hospitals across Pennsylvania.

House Bill 106, which would set minimum direct care nurse staffing ratios for patient care for various levels of care, passed the state House of Representatives and awaits action in the state Senate.

As a nurse for more than 25 years, I can vouch for the attention that is required to appropriately care for a patient. By requiring hospitals to maintain staffing ratios, patients can feel confident that they will receive adequate care, while ensuring that nurses are not unnecessarily overwhelmed in what is already a stressful job.



## MEDICAL DEBT **RELIEF PLAN PASSES HOUSE**

It's time that we create the PA Medical Debt Relief program in Pennsylvania.

People in debt because they, or a family member, are fighting a disease should not be harassed by a debt collector. This program would erase the medical debt of thousands of financially vulnerable state residents.

As a prime co-sponsor of this bill, I was glad to see it pass the House by

a bipartisan vote, and it is now in the state Senate.



## HISTORIC BREAST CANCER SCREENING LAW

Early last year, I supported legislation, which was later signed into law, that will be a major step forward in the fight against breast cancer and help save lives.

Act 1 of 2023 removes out-of-pocket costs associated with genetic testing for hereditary breast, ovarian, prostate, and other cancer syndromes – as well as supplemental breast screenings for women with a high lifetime risk of breast cancer.

This landmark legislation is the first of its kind in the nation and will ensure that critical health care will be accessible and more affordable for more Pennsylvanians.



## \$10 MILLION IN STATE GRANTS TO HELP OUR AREA

One of the most gratifying parts of my job as your state Representative in Harrisburg is seeing your tax dollars returned to our area through various state grant programs. Many of the projects funded by these grants would either not be possible for local governments to afford, or they would require local taxes to be increased.

### MORE MONEY IN YOUR POCKET

The number of people struggling to get by is only growing, especially among our seniors.

For almost 20 years, many people lost access to the Property Tax/Rent Rebate Program because of small changes in their income. A new law, which I voted for, will help thousands more people in Lackawanna County, renters as well as homeowners, to stay in the homes and communities they love. The expansion:

- ✓ Raises the income limit to qualify for rebates to \$45,000 for both homeowners and renters.
- ✓ Ensures this income cap will keep pace with inflation.
- ✓ Increases the maximum rebate from \$650 to \$1,000.



At the bill signing for the expanded PTRR Program were Attorney Pat Brier, a long-time advocate for senior citizen and consumer issues, along with former PA Secretary of Aging and former Lackawanna County Director of Area Agency of Aging Teresa Osborne of Scranton.

Remember, when calculating your yearly earnings, you need to claim ONLY half of your yearly Social Security allocation to qualify.

## PA MUST INVEST IN SCHOOL FACILITIES

My Democratic colleagues and I recognize that the state must take action to address outdated and toxic school buildings in Pennsylvania.

We passed legislation, now law, that would start to fund the construction and improvement projects that are required to bring so many of our schools into the 21st century.

Lead, asbestos, radon, mold and other hazardous elements are frequently found in our schools, which has significant short- and long-term effects on children and faculty. As a practicing nurse for 25 years before becoming a legislator, I know that these negative impacts range from physical health and safety to academic achievement. Toxic schools are a public health crisis, and we need to clean them up to keep our kids and school staff safe.



# STATE BUDGET DELIVERS HISTORIC INVESTMENT IN PUBLIC SCHOOLS

While the 2023-24 state budget isn't perfect, I believe there are some great things in it to help Pennsylvanians. Here are a few highlights:

- A historic \$8.4 billion in basic education.
- · Childcare services to help parents earn a living.
- Support for hospitals that continue to face post-pandemic challenges.
- Public safety and violence reduction programs to make our communities safer.
- Veterans' and seniors' programs.
- Reauthorization of the Whole-Home Repairs program, which will allow countywide agencies to do more to address habitability and safety concerns, improve energy efficiency and make homes accessible for those with disabilities.
- A universal free breakfast program for students.
- Funding for the state's first-ever public legal defense fund to support no-cost legal representation to those who have been accused of a crime but cannot afford an attorney.







I went on the road with many of my fellow state representatives listening to our residents about issues that they are facing in their respective neighborhoods and school districts.

## **BIGGER CHILD & DEPENDENT CARE TAX CREDITS**

House Democrats fought and won for working families, prioritizing a significant increase in the Child and Dependent Care Enhancement Tax Credit.

This tax credit eases the burden for working families who pay for and rely on child and dependent care to work. The tax credit can be claimed on federal and state tax returns.

Eligible families who qualify for the federal Child and Dependent Care Tax Credit are eligible for the and services. Please contact my state tax credit, which had been equal to 30% of the federal credit. PA will now provide a 100% match

to the federal tax credit. Families will see their state tax credits more than triple.

Prioritizing access to affordable child and dependent care is a win for families, a win for our workforce, a win for businesses and a win for our economy.

## IT'S TIME TO RAISE THE WAGE IN PA

Every state surrounding Pennsylvania has a higher minimum wage than we do. It is past time for us to help thousands of Lackawanna County workers, and the state House of Representatives took a step in that direction by passing H.B. 1500 with my yes vote.

The bill would raise the minimum wage incrementally until it reaches \$15 per hour, and it also includes a mechanism for future increases to keep up with inflation.

This bill awaits action in the state Senate.
